## Summary of key findings

### This provision meets requirements

- Staff provide a variety of toys and resources that are suitable for a range of different ages. The indoor and outdoor environments are spacious and inviting. Staff understand how to plan interesting and enjoyable activities for children.
- Staff know how to safeguard children and protect them from potential harm. They understand what to do if they have concerns about a child's welfare. They access regular training to keep their knowledge and skills up to date. Staff demonstrate a good understanding of how to recognise and protect children who may be at risk of being exposed to extreme views or behaviours.
- The manager recognises the importance of evaluating the provision. She explains how she gathers feedback from parents, children and staff, and uses this information to help her to make continuous improvements to the club.
- Staff understand the importance of carrying out regular risk assessments to minimise hazards and provide a safe environment that promotes children's general well-being. They understand their responsibility to supervise children to keep them safe.
- Staff understand how to positively promote and manage children's behaviour. They recognise the importance of supporting children to use good manners, take turns in their play and to show respect to each other.
- Staff know how to promote children's good health. They understand how to provide children with nutritious snacks and meals, and opportunities to be physically active.
- The manager recognises the importance of providing an inclusive environment. She explains how staff support children to develop positive self-esteem and confidence.
- Staff understand the value of working in partnership with parents and the host school to support the continued care and education of the children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Pury Play Club registered in 2017 and is located in the grounds of Paulerspury Primary School, Towcester. The club employs three members of childcare staff, two of whom hold early years qualifications at level 3. The club operates from Monday to Thursday all year round. The club offers sessions before and after school during term time, and during school holidays, sessions are from 8am until 5.30pm.

- The inspector held discussions with the manager and staff. She checked evidence of the suitability of staff working with the children.
- The inspector viewed a sample of documentation, including policies and procedures.
- The inspector observed the safety of the provision indoors and outdoors.
