Summary of key findings

This provision meets requirements

- The childminder has a detailed knowledge of safeguarding. She knows the signs that may indicate a child is at risk of harm and what to do if she has concerns. The childminder ensures her knowledge of safeguarding is up to date. She has an excellent understanding of how to work with other agencies to ensure children are kept safe.
- The childminder understands how young children learn. She knows how to monitor their individual learning needs and plan challenging activities to help them to make good progress. The childminder demonstrates her sound knowledge of child development and how she will use her home, resources and outdoor play area to support children's progress. She is aware of how to use her observations of children's play to accurately plan interesting activities to support their learning.
- The childminder is friendly and welcoming. She has a thorough understanding of how to provide an inclusive setting where children's unique achievements are celebrated.
- The childminder understands the value of working in partnership with parents and other professionals involved in children's lives. She knows how to use these partnerships to help meet children's individual needs and support continuity in their learning. She describes the appropriate methods used for engaging parents and encouraging them to share what they know about their child. She recognises the importance of finding out about children's care routines when they start attending.
- The childminder reflects on the quality of her practice to identify areas for further development. She is committed to continually improving her service and attends regular training to support her professional development.
- The childminder describes how she will manage children's behaviour in a supportive way. She understands that children need to gain a positive view of diversity and respect any differences between themselves and others.
- The childminder has a clear understanding of how to help children form close bonds and attachments to her and other children to support their emotional development. She describes how she will help them to learn self-care skills, independence and social confidence in readiness for school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
