Summary of key findings

This provision does not meet requirements

- The childminder is unable to provide evidence of her first-aid training. She does not have this documentation available to show that she is meeting all the required regulations.
- The childminder does not have public liability insurance in place.
- The childminder has not kept her knowledge of how to safeguard children up to date. She does not know the relevant agencies to contact if she is concerned about a child's well-being or if an allegation is made against her. The childminder has not completed the required training for being a lead practitioner for safeguarding and has limited knowledge of wider legislation.
- The childminder demonstrates limited knowledge of the learning and development requirements of the early years foundation stage.
- The childminder knows how to gain detailed information from parents to enable her to support children's individual care throughout the day.
- The childminder understands how to promote positive behaviour with children in order to support and develop their confidence and self-esteem.
- The childminder understands how to promote children's well-being. She demonstrates, through discussion, how she intends to provide daily opportunities for children to visit local parks and playgroups to enjoy fresh air and exercise.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
