Summary of key findings

This provision does not meet requirements

- The childminder does not have a clear understanding of how to provide younger children with opportunities and resources to develop their skills across the different areas of learning. In addition, she does not have resources for younger children to use and enjoy at the setting.
- The childminder does not recognise the need to evaluate and address all weaknesses in her provision. Therefore, she does not meet the requirements of the Early Years Register.
- The childminder knows how to access opportunities to maintain her overall professional development. However, she has not identified the need to enhance her skills and knowledge for working with younger children.
- The childminder has knowledge of child protection issues and wider safeguarding issues. She knows how to record and report any concerns and allegations to the relevant authorities. The childminder knows how to complete risk assessments of her home to ensure it is safe for children.
- The childminder describes some opportunities to support children's personal, social and emotional development. She knows how to help children to manage their feelings and how to offer encouraging words to promote positive behaviour.
- The childminder knows how to form relationships with parents to share information between the child's home and the setting. She understands the importance for parents to know her policies and procedures so that they are aware of what to expect from her service.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:
