**Overall outcome** 

The school is likely to meet the relevant independent school standards if the material change relating to the school provision is implemented

## Main inspection findings

### Part 1. Quality of education provided

All paragraphs

- Leaders wish to extend the school's age range to include a sixth form, opening in September 2020. Leaders have clear plans and schemes of work in place for the proposed sixth-form curriculum, using the International Baccalaureate Diploma programme (IBDP).
- Plans and schemes of work are closely linked to the IBDP, and encourage progression in developing students' knowledge. The subjects planned include: English language and literature; French, Spanish, Italian and Mandarin; history, geography, economics and business studies; chemistry, physics and biology; mathematics; and art. These subjects will ensure that the curriculum provides students with the required breadth of knowledge and experience and prepare them for success at university and life beyond.
- The educational provision proposed for the sixth form closely matches the school's aims and ethos. This includes study across the academic disciplines, sport and the performing arts. Leaders plan that the sixth-form curriculum will build on students' critical thinking and creativity.
- Experienced and well-qualified teachers have been appointed to deliver and lead on the sixth-form curriculum.
- Leaders will monitor the consistency and quality of education provided. A framework of assessment based on the requirements of IBDP will be used to track students' progress. Leaders plan to assess students' work appropriately and for teachers to use this information to plan teaching accordingly. The assessment information will be shared with students, parents and carers.
- The provision will take into account the ages, abilities and special educational needs and/or disabilities of the students to be admitted. For example, the new building will have a lift to all floors to ensure that students, especially those with disabilities, have



access to the full curriculum.

- Leaders have given suitable consideration to the development of students' speaking, listening, literacy and numeracy skills.
- The building plans show that classrooms will be suitably equipped to support students' learning. Some classrooms will have specialist facilities. For example, the chemistry laboratory will be equipped with appropriate apparatus and fume cupboards for experiments.
- Students will have access to local sports grounds for physical education and a range of sporting activities.
- A suitable programme for personal, social, health and economic (PSHE) education will be offered as a discrete subject. PSHE education will also be promoted through other areas of the curriculum, including extra-curricular activities.
- Students will be provided with sufficient opportunities to learn about British values and equality. They will be encouraged to respect other people, including those who have protected characteristics.
- Leaders have made suitable arrangements to ensure that students have access to regular, impartial and high-quality careers information, advice and guidance.
- Leaders have ensured that all the independent school standards in this part are likely to be met if the proposed material change is approved and implemented.

### Part 2. Spiritual, moral, social and cultural development of pupils

### All paragraphs

- Leaders have made appropriate plans for students' spiritual, moral, social and cultural (SMSC) development. Most of this work will take place through a regular programme of PSHE education.
- Plans are in place for the sixth-form students to be involved in leadership programmes to develop their self-confidence and initiative through taking on greater responsibilities. The curriculum is designed to strengthen their knowledge and understanding of democracy, tolerance and freedom.
- The proposed sixth-form curriculum is carefully mapped to promote students' SMSC development. This includes the teaching of British values and ensuring that students are encouraged to show respect for all groups, including those with protected characteristics.
- It is planned that the sixth-form students will continue to contribute positively to the lives of others through fundraising and charity work.
- The PSHE education curriculum will contribute to students' understanding about different cultures and religions and prepare them for life in modern Britain.
- Students will be involved in discussions and debates. They will be offered balanced points of views by teachers and given time for discussion and reflection.
- The curriculum will be enriched by a wide range of extra-curricular activities, including sports, arts and educational visits.

### Part 3. Welfare, health and safety of pupils

- Leaders have recently updated the safeguarding policy to ensure that it meets the current statutory requirements. A copy of the current safeguarding policy is available from the school's website and made available in hard copy to parents on request.
- Leaders ensure that all staff receive regular training on safeguarding and child protection procedures. Leaders ensure that staff fully understand their responsibilities to keep pupils safe. Senior staff who have the responsibility for leading on safeguarding are knowledgeable about their role and are appropriately trained.
- Leaders have a secure understanding of safeguarding issues. Pupils who spoke to the inspector said they always feel safe and are well cared for.
- Leaders have ensured that all the independent school standards in this part are likely to be met if the proposed material change is approved and implemented.

### Part 8. Quality of leadership in and management of schools

All paragraphs

- Leaders and governors demonstrate strong knowledge, understanding and skills appropriate to their roles. The independent school standards are met consistently.
- Governors are highly experienced. They skilfully support and challenge leaders appropriately. They hold leaders to account so that pupils are safeguarded and the school continues to improve.
- Leaders and governors have worked closely to design the new building, including the provision for the sixth form. Therefore, it is likely that all the independent school standards will be met. The proposed sixth-form curriculum is well thought through to meet the needs of the students. This links to the aims and ethos of the school.
- Leaders are committed to keeping students safe. Students' welfare, health and wellbeing are a priority at the school.
- Leaders have ensured that all of the paragraphs in this independent school standard are likely to be met if the proposed material change is approved and implemented.

- There are currently 205 pupils in the pre-preparatory phase (Reception to Year 2), 444 pupils in the preparatory phase (Years 3 to 8) and 50 pupils in the senior phase (ages 13 upwards).
- The headteacher was appointed in September 2018.
- There are plans in place to move the senior phase with a new sixth-form into new premises at Chesilton Road, London SW6 5AA in September 2020.

## Information about this inspection

- The school's last standard inspection was in September 2017, when it was judged to be good.
- The school received a material change inspection on 25 April 2018 to consider the school's application to extend the age range of pupils taught at the school from 4 to 14 to 4 to 16. The material change inspection judged that the school was likely to meet the relevant independent school standards if the material change was implemented.
- This material change inspection was commissioned by the Department for Education (DfE) to consider the school's application to extend the age range of pupils taught at the school from 4 to 16 to 4 to 18 so that the school can teach students in the sixth form, commencing in September 2020. The DfE commissioned this inspection to check against the independent school standards in parts 1, 2 and 34. In addition, paragraphs 7, 7(a), 7(b), 32(1) and 32(1)(c) were checked in relation to the school's safeguarding policy and its implementation and publication.
- The inspection was conducted with two days of notice.
- The inspector scrutinised the school's website and a range of school policies and documentation, including the proposed sixth-form curriculum. Key documents and policies relating safeguarding, pupils' welfare, and health and safety were reviewed. The inspector took a short tour of the school site. The school's plans and proposals for the new building to accommodate the sixth form were considered. Discussions were held with the headteacher, governors, senior leaders and managers, and pupils in key stages 3 and 4.
