The quality and standards of early years provision

What is it like to attend this early years setting?

This provision does not meet requirements

Children are not safe and protected. The provider does not ensure that at least one member of staff with a paediatric first-aid qualification is available at all times to meet children's needs in the event of an accident. Staff do not have a clear understanding of how to protect children in their care and the procedures to follow in the event of an allegation. The provider does not have a clear understanding of her responsibility to inform Ofsted of changes to people who manage the setting. Required documents such as staff suitability checks were not available for inspection. Repeated breaches of the safeguarding and welfare requirements of the early years foundation stage mean that children's welfare and well-being are significantly compromised.

Nevertheless, children feel included and enjoy a friendly and welcoming learning environment. They enjoy a variety of activities which are of interest. For example, they enjoy playing card games and art and craft activities. They enjoy daily outdoor activities where they can release energy and get fresh air. This positively supports their physical and mental well-being. Children engage in ball games, run and catch games and playing with hula hoops and skipping ropes. They have fun playing together, sharing ideas and building positive friendships. They show respect for each other and happily engage in conversations, listening and responding positively to ideas and suggestions. Children do not mind trying new things and show good levels of curiosity and enjoyment when engaging in activities.

What does the early years setting do well and what does it need to do better?

- The leadership and management of the provision are not effective. Staff are not fully aware of who is part of the leadership and they do not feel supported in their role. The new operational manager has not had the support and training needed to fulfil her role effectively. Overall, the provider does not engage effectively with staff and does not provide opportunities for staff to discuss any concerns or help identify their training needs.
- The staff working directly with the children reflect on the provision and share ideas to help ensure children have a positive experience at the setting. Staff implement a reflection time at the beginning of each session to help children talk about their day. They encourage children to use descriptive language and learn new words, according to children's ability. This helps children with their communication skills.
- The provider does not monitor the quality of the provision effectively to identify and remedy all weaknesses in practice. She has not ensured that previous actions are addressed. For example, she has not ensured that there is at least one member of staff present at all times who is trained in providing paediatric



- first aid. Children's safety if not assured.
- Staff provide children with healthy snacks, taking into consideration their dietary requirements, to help support their overall well-being.
- Parents are very happy with the setting and comment on the effective communication. They value the face-to-face chats with staff, when picking up their children, as well as the regular emails.
- Staff involve children in routine tasks to help build their sense of responsibility, such as tidying away resources and clearing up after snack.
- Children's attitudes and their views about the setting are positive. They say that they enjoy playing with their friends and having fun. Staff use their discussions with children to help them plan activities that ignite children's interests. Children have access to a suitable range of resources and make independent choices in their play.
- Leaders do not ensure that all staff are clear about the safeguarding procedures, including how to report a concern about another member of staff to the relevant outside agencies. The provider has not ensured that documents such as staff files are stored securely and are available during inspection. These weaknesses have a significant impact on children's safety.

Safeguarding

The arrangements for safeguarding are effective.

Leaders do not ensure that all staff have a secure safeguarding knowledge, especially regarding the procedures to follow if there is an allegation against a member of staff. Staff are not aware of the relevant agencies outside the provision that they need to report to, should they have concerns. This puts the safety of children at risk. Staff undertake daily checks of the indoor and outside areas, to ensure the suitability of the premises and equipment for children's use. However, there is no member of staff who has a valid paediatric first-aid certificate. This means that, should there be an accident, there is no qualified staff member available to administer first aid. This puts children's well-being at risk.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:
