Summary of key findings

This provision meets requirements

- The childminder describes how she will use assessments to plan for children's future learning and address any gaps in their development. She talks about how she plans to complete the required progress check for children at age two and work closely with parents.
- The childminder shares how she will provide resources appropriate to the ages and abilities of the children attending.
- The childminder talks about how she will promote children's positive behaviour. She describes the strategies she will use to help them to learn to share and consider the needs of others.
- The childminder verbally demonstrates an appropriate understanding of carrying out risk assessments to identify and minimise hazards to children in the home and on outings.
- The childminder understands how to improve her provision, for instance, through evaluating her practice and by attending training courses.
- The childminder holds a current paediatric first-aid certificate.
- The childminder describes how she will support children's well-being. For example, she plans to provide daily opportunities for children to exercise and to be outside in the fresh air.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector checked evidence of suitability of the childminder and people living in the home.
- The inspector talked to the childminder about how she keeps children safe.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
