What is it like to attend this early years setting?

This provision does not meet requirements

The management team demonstrates a significant weakness in understanding the Early Years and Childcare Register requirements. It has failed to notify Ofsted of the changes made to the nominated individual, provider and manager at the setting. The management team has recruited staff without keeping a written record of the person who obtained the vetting and Disclosure and Barring Service checks. This is a significant breach of their requirements. The management team does not ensure that all staff understand their safeguarding policies. They have a poor knowledge of child protection procedures, and requirements relating to the safe administration of medication. As a result, children's health, safety and well-being are significantly compromised.

The manager and staff provide a stimulating environment for children. They plan a range of activities and equipment which helps to keep children engaged and interested in their play. Staff have high expectations of children's behaviour and model this well through their kind, caring and nurturing approach. Consequently, children demonstrate they feel happy and settled at the club.

What does the early years setting do well and what does it need to do better?

- The management team demonstrates a significant weakness in understanding how to meet the Early Years and Childcare Register requirements. For example, it has failed to notify Ofsted of the changes made to the nominated individual, provider and the manager of the setting. This is a significant breach of requirements and prevents Ofsted from having the up-to-date information about the individuals responsible for the setting.
- The management team does not ensure that all staff have a sufficient understanding of all safeguarding policies and procedures. For example, some staff have a weak understanding of the correct procedures to follow if they have concerns about the welfare of a child or another member of staff. This includes how they would share information confidentially with appropriate agencies.
- Staff do not obtain prior written permission from parents to administer their child's life-saving medications. This puts children's health and well-being at significant risk.
- Staff do not keep an accurate record of the dates and the dose of medication that they have administered to a child. This provides inaccurate information about whether a child has received the correct dose of medication and when this is next due. Children's health and well-being are at significant risk.
- The management team does not keep a written record which includes the name of the person, or company, who obtained the vetting and Disclosure and Barring Service checks for all staff.



- The management team recognises the importance of developing strong relationships with children and their parents. It regularly seeks feedback from parents and children to evaluate the quality of their setting and play equipment. The manager considers their views and implements their suggestions into effective provision plans and activities.
- The manager and staff team provide a welcoming environment for children. They plan a wide range of play equipment and activities according to children's interests. Staff build strong relationships and interact well with children during their play. This helps to keep children engaged and motivated.
- Children enjoy the wide range of healthy snacks staff prepare for them. They benefit from the time they spend outdoors playing with their friends in the fresh air. Children use climbing equipment and join in with sports games and activities. They work well together as a team and celebrate their friends' achievements. Children demonstrate high levels of confidence and self-esteem.

Safeguarding

The arrangements for safeguarding are not effective.

Significant weaknesses in leadership and management compromise the extent to which children are protected from potential harm. Leaders have failed to ensure that staff have a good enough understanding of child protection procedures to ensure children's safety. In addition, vetting records are not completed in line with requirements, to ensure the suitability of staff working at the club. In addition, leaders do not recognise the importance of keeping Ofsted up to date with changes to the people responsible for the setting.

What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:

- The inspector reviewed a sample of policies, procedures and other records regarding health and safety.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
