Information about this children's home

The home is registered to provide care and accommodation for up to three children who have social, emotional and behavioural difficulties. The home is owned and operated by a private provider. The manager has been registered since February 2019. The manager is currently undertaking the required qualification for residential managers.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At this interim inspection, Ofsted judges that it has sustained effectiveness.

Children receive good, nurturing care from a committed group of staff. Children make good progress overall. This is particularly the case in education. Most children attend school regularly, enjoy school and are becoming more confident in their abilities. When children refuse to attend school, the manager works in partnership with other agencies to identify alternative ways to meet their educational needs.

The manager and staff advocate strongly for children to make sure that children receive the services they need. For some children, this has meant securing the right emotional and mental health input. As a result, children become more settled and increasingly resilient.

The views of children are taken seriously. Children know how to make complaints if they feel aggrieved. The manager and staff take complaints seriously and do all they can to achieve a satisfactory resolution. Children also express their views and opinions through regular children's meetings. The manager provides a response to children's views expressed in these meetings. This helps children to feel that their views matter.

Children's behaviour has, at times, become unsettled. Staff have managed incidents well. The manager evaluates the effectiveness of staff members' responses to incidents. She supports staff to take a reflective approach so that lessons can be learned. When the practice of staff has fallen short of expectations, the manager has taken the correct action immediately. Since the last inspection, there has been a reduction in the number of incidents. This indicates that some children are becoming more settled.

Staff have a better understanding of how to keep children safe because risk assessments are detailed and include effective strategies to reduce risk.

The manager has acted on the three recommendations made at the last inspection. This has resulted in better management oversight, improved recording and more effective behaviour management plans.

Staff receive good training and professional development. They receive monthly supervision. A psychotherapist meets with the team regularly. These meetings are helpful because they enable good staff to reflect on how they can improve the care and support provided to children.

The manager uses a range of tools that help her to continually evaluate the quality of care provided to children. The manager values the monthly visits from the independent person because they identify areas of relative weakness and help the manager to improve the home. However, the manager has not always ensured that the visitor has been able to speak to professionals, parents or carers.
