## **Acorn Children's Home (Branston) Limited**

Monitoring visit

Inspected under the social care common inspection framework

### **Information about this children's home**

This privately owned children's home is registered to provide care for up to four children who have moved following a breakdown in either their fostering or residential placement, or who are required to live away from home.

The current manager started in post in July 2019 and has submitted his application to register with Ofsted.

**Inspection date:** 8 November 2019

### **This monitoring visit**

This children's home was judged inadequate at the last full inspection. A suspension of registration notice was issued on 23 September 2019.

The purpose of this inspection was to review the provider's continued compliance with the suspension of registration notice. The inspector found that the provider is continuing to abide by the suspension of registration notice.

The provider is currently actively recruiting staff to work at the home. As a result, at the current time there is an insufficient number of staff for the home to be operational.

All the requirements raised at the inspection in September 2019 remain within the timescale for completion. The manager has an initial plan to address these once the home has sufficient staff in place. Consequently, the impact of any of these proposals is currently untested.

<p>The leadership and management standard is that the registered person enables, inspires and leads a culture in relation to the children’s home that helps children aspire to fulfil their potential; and promotes their welfare.</p> <p>In particular, the standard in paragraph (1) requires the registered person to ensure that staff –</p> <p>have the experience, qualifications and skills to meet the needs of each child;</p> <p>ensure that the home’s workforce provides continuity of care;</p> <p>understand the impact that the quality of care provided in the home is having on the progress and experiences of each child and use this to inform the development of the quality of care provided in the home;</p> <p>use monitoring and review systems to make continuous</p>	21/11/2019

improvements in the quality of care provided in the home. (Regulation 13(1)(a)(b)(2)(c)(e)(f)(h))	
The registered person must maintain records ('case records') for each child. Case records must be kept in a secure place after the child has ceased to be accommodated in the home. (Regulation 36(1)(2)(d))	21/11/2019
