## Information about this children's home

This is a privately owned children's home. It is registered to provide care and accommodation for up to four children and/or young people.

Inspection date: 11 November 2019

## This monitoring visit

At the interim inspection, Ofsted judged that this home had declined in effectiveness.

Ofsted found that the provider had not maintained safe recruitment procedures to ensure that only suitable adults work with children. The provider had not carried out essential recruitment checks to help them to determine a person's fitness to work with children.

As a result of this failure, Ofsted issued a compliance notice in respect of regulation 32 of the Children's Homes (England) Regulations 2015.

On 11 November 2019, Ofsted conducted a monitoring visit to the provider's head office. The inspector found that the provider has taken action to meet the compliance notice.

Training, policy, procedure and practice in safe recruitment have been improved. The provider is no longer employing any disqualified person and is now carrying out all the required recruitment checks to help them to determine someone's suitability to work with children. Consequently, the provider now has regard for legislation designed to protect vulnerable children.

Each child's talents and interests should be understood and nurtured, with children selecting activities based on their personal preferences and abilities, so far as is reasonable. Staff should also support children to try activities that are 'new' for them, where appropriate. ('Guide to the children's homes regulations including the quality standards', page 31, paragraph 6.4)
