What is it like to attend this early years setting?

The provision is good

Staff are positive role models. They join in children's play, show them how to use equipment and develop their learning by offering ideas. For example, staff encourage children to explore the range of vegetables in the home corner. They talk about the size and shape of each vegetable as well as how to prepare them for eating. This helps to support children's development of vocabulary and their ability to play imaginatively. Staff prioritise time to share books with children. Children giggle with excitement as they snuggle up and join in with familiar words and phrases. They demonstrate a love of reading from a young age.

Staff give lots of praise and encouragement during activities, which supports children's confidence and self-esteem. Children learn to lead healthy lifestyles. They enjoy a variety of nutritious foods. Staff encourage children to manage tasks for themselves. For example, they learn to put on their own coats and boots when going outside. Children are very well behaved and form firm friendships with one another. Staff reinforce positive behaviour. Clear routines are a part of each day. These help children to understand what will happen next. For example, even the youngest children notice the snack tray arriving and head off to wash their hands.

What does the early years setting do well and what does it need to do better?

- The manager has worked with the support of the local authority advisory team to make improvements since the last inspection. She is determined to continue to improve the provision. For example, she has developed procedures that ensure staff are clear about which rooms they are working in. This ensures that children are sufficiently supervised at all times. Staff feel supported and comment they have worked together to make positive changes in the setting.
- Managers and room leaders strive to constantly look at ways to improve their practice. They are proactive in implementing changes that help children to make the best possible progress.
- The key-person system is effective, and children's individual needs are well known by all staff. Cuddles are readily available. Children form strong bonds with staff, which supports their emotional development. The key persons and parents agree individual settling-in arrangements according to the needs of each child.
- Children are encouraged to develop problem-solving skills. They are given time and space to explore freely, with adults on hand to offer support and suggestions where needed. For example, children explore outside with pipes, guttering, containers and funnels. They spend long periods of time observing what happens as they pour sparkly water through the different equipment. Children are challenged to see how much water they can move along a series of pipes. Children notice that there is a leak part way along and offer suggestions



- about what might help them fix this. Staff listen to children's ideas and provide them with materials to try out their thinking.
- The staff are supported to enhance their teaching skills. They use this knowledge to respond effectively to children, to extend children's learning and understanding. For instance, when children are playing with trains, staff extend their learning by introducing them to new and challenging vocabulary. Staff explain that the trains have a magnet on each end and that they join when positive and negative poles are put next to each other.
- Staff do not always recognise the opportunities that arise during children's play to build on their understanding and learning of numbers and counting.
- Staff build warm and friendly partnerships with parents. They keep parents informed about their children's development and invite their thoughts. Parents speak highly of the nursery and say they value the staff's support.
- Children have ample opportunities to do things for themselves, which helps them develop independence. Children enjoy serving themselves from a range of foods and pouring water into their cups at mealtimes.
- The manager observes staff practice and carries out regular supervision meetings to manage their well-being and performance. Training is well targeted to meet staff's individual professional development needs and helps to maintain the good quality of practice.

Safeguarding

The arrangements for safeguarding are effective.

Staff always supervise children and maintain the required staff-to-child ratios. This helps to ensure that children are kept safe from harm. The premises are safe and secure. Staff carry out daily checks of the premises and garden to make sure potential risks are minimised. The manager and staff have a good understanding of how to protect children. They complete safeguarding training to ensure that they have a secure knowledge of the procedures to follow if they identify any concerns about a child's welfare. Staff know who the designated person for safeguarding is, and they are aware of how to report any concerns they have about children.

What does the setting need to do to improve?

To further improve the quality of the early years provision, the provider should:

make the most of opportunities that arise to support children to develop skills in number and counting.

- The inspector observed activities indoors and considered the impact of teaching on children's learning and development.
- The inspector spoke to staff and children at appropriate times during the inspection.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
