This monitoring visit

This monitoring visit was carried out after Ofsted received concerns about children's care. These concerns relate to children not feeling that their views, wishes and feelings are taken into account when decisions are made. Furthermore, concerns have been raised that the boarding accommodation is not maintained to a good standard.

During this visit, inspectors spent time speaking to some of the children and looked at a few children's bedrooms. Inspectors also used questionnaires to help to secure as many children's views as possible about their boarding experience. Some of the questionnaires were left with stamped addressed envelopes, to give any children who were not seen during the visit the opportunity to express their views to Ofsted.

During the visit, inspectors found no concerns regarding children's bedrooms. Children who were met said in regard to the boarding provision that they felt they were listened to and that their views, wishes and feelings were respected.

Information about this school

Madinatul Uloom Al Islamiya is an independent Islamic boarding school for boys, dedicated to providing Islamic as well as secular education. Opened in 1992, it has a 22-acre rural site four miles southeast of Kidderminster. All teaching blocks and residential accommodation are set within the college campus. Students are allocated to boarding hostels according to their age group. There are currently 230 students on roll, aged from 12 to 24. There are no students with learning difficulties and/or disabilities and none at an early stage of acquiring English. Madinatul Uloom aims 'to educate the students and instil in them the teachings of the Holy Qur'an and practices of our Holy Prophet Muhammad (peace be upon him) as well as other arts and sciences. It also strives to promote and cultivate good behaviour, morals, mutual respect and tolerance. This in turn creates a friendly, caring and motivated environment.' This inspection focused on those under 18, who lived in three of the five boarding houses. The school was last inspected in October 2019.
