Summary of key findings

This provision meets requirements

- The childminder has a secure knowledge of safeguarding procedures and has appropriate policies in place. She is able to recognise signs of potential abuse, including when a child may be at risk of being exposed to extreme ideas and behaviours. She knows how to escalate concerns regarding the welfare of a child.
- The childminder values working in partnership with other early years providers to share curriculum ideas, provide emergency cover and build a network to help further evaluate practice. She includes parents' views when reflecting on her practice and considering areas where she could improve her skills and knowledge. This benefits children's overall learning.
- The childminder has a good understanding of the early years foundation stage requirements. She knows how to assess children's development and uses this information to plan challenging next steps to help them make progress.
- The childminder knows how to create a safe environment for children and understands the benefit of play, to help support children's emotional well-being. She provides resources appropriate to children's stage of development and opportunities for them to explore the natural environment, such as in the garden and during sensory walks.
- The childminder understands the importance of setting clear boundaries and expectations to help children understand right and wrong.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
