Summary of key findings

This provision meets requirements

- The manager and staff understand how to safeguard children. They are extremely well trained and knowledgeable with regards to their roles and responsibilities in keeping children safe.
- The manager has high expectations for the setting and she uses robust self-evaluation procedures to make improvements. Regular audits are completed and this allows areas for development to be quickly spotted and changes made.
- The manager recognises the importance of close partnerships with parents and other professionals. She understands her responsibilities to assess children's learning and development and to share this information with the necessary people.
- The manager has a strong understanding of the early years foundation stage and how children learn. She plans activities based on children's individual interests and next steps.
- The manager and staff complete daily risk assessments and make sure the premises are safe and secure for children at all times.
- Children's progress is regularly assessed and this information is shared with parents. Parents are given opportunities to share their own observations, which staff use to plan future activities.
- The manager monitors staff's performance in depth. For example, she regularly observes staff's practice and holds supervisory meetings with them to discuss and create plans to enhance their in-depth knowledge further.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

There are two members of staff with qualifications at level 4 and above. The nursery receives funding to provide free early education for children aged two and three years.

- The inspector looked at the suitability of the premises that staff and children use.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
