

# Inspection of Kings Heath Playcare

Kings Heath Primary School, Valentine Road, Birmingham, West Midlands B14 7AJ

The quality and standards of early years provision

### What is it like to attend this early years setting?

### This provision does not meet requirements

The management committee, who are responsible for running the provision, do not have a sound enough understanding of their key roles and they are not all suitably vetted. Staff are lacking confidence and their safeguarding knowledge is not secure. Overall, they do not have a clear understanding of all their responsibilities to help meet all legal requirements and maintain high standards. That said, managers complete risk assessments of all areas in use. Staff conduct daily opening checks to ensure the resources and equipment are still suitable. However, staff do not always supervise children as carefully as possible. Children move freely between the areas in use, including accessing the cloakroom and toilet, which due to their location is not appropriate. This does not help to keep them fully safe. That said, children are settled and happy to attend. They greet staff warmly and are keen to talk to them. However, on entry to the club, children are kept waiting around for unnecessarily long periods of time as staff do not confidently carry out the playscheme routine or set up play activities quickly enough. Nevertheless, during the session, some children enjoy playing with small-world play characters and a castle, role play in the home corner and decorating Christmas bookmarks, making picture frames and colouring or painting Autumn pictures. However, there are also occasions when activities are too formal or lengthy, such as whole-group sessions to talk about the behaviour expectations or story time. Therefore, children struggle to pay attention and keep focus. Furthermore, on occasion, staff only provide access to limited activities and therefore, those not wanting to join in struggle to choose something to do. Overall, staff do not fully help children make the most of the time they spend in the playscheme.

# What does the early years setting do well and what does it need to do better?

- The management committee of the playscheme do not fully understand their key roles. They have failed to notify Ofsted of new committee members and provide them with all the information they require to complete appropriate vetting checks in a timely way.
- Staff knowledge of child protection issues and wider safeguarding concerns, including the 'Prevent' duty is not strong enough. This does not help to keep children fully protected from different types of harm.
- Children are not always supervised well when accessing certain areas. The cloakroom and bathroom is located out of sight and hearing of the main playscheme rooms. Staff sometimes send children off on their own to put things in their bags or use the toilet, which does not fully promote their welfare at all times.
- Managers observe staff's practice, conduct formal one-to-one supervisions and informal welfare meetings with them on a regular basis. However, they do not



- make the most effective use of these processes to ensure staff have all the knowledge and skills they require to fulfil their roles.
- Staff deployment is not always effective. Due to staffing rota systems, allocated key persons do not get to spend enough quality time with their key children. Therefore, they do not get to know them as well as possible to help them build the most positive relationships with them and their families.
- Children's physical well-being is promoted in some ways. Staff find out about children's individual care needs and ensure these are met. They are rigorous in promoting hygiene and teach children about washing their hands properly. Children are independent and can manage their self-care needs with minimal support, such as putting away their belongings when they initially arrive. Staff also offer children a menu of diverse and nutritional foods. They talk about the benefits of eating well and encourage them to try new things. Children talk about their likes as they tuck into naan breads and curry sauce for snack.
- Staff do not continually ensure that the activities and experiences provided are tailored towards promoting children's interests and where appropriate supporting their individual needs. Therefore, there is room to broaden them to help children make the most of the time they spend in the playscheme.
- The playscheme is very inclusive. Staff help children to explore diversity and they ensure any children with additional needs benefit from targeted support. Overall, staff manage behaviour in a suitable way. Children chat socially to their peers, they invent their own entertainment when they are not motivated by what has been provided and are happy to play collaboratively with others.
- Partnerships with parents, the host nursery and school and relevant external professionals are established. Staff share basic two-way information about children's care, development and any specific needs. Parents comment that they are happy with the service provided.
- Self-evaluation is in place. Managers who run the setting day-to-day are passionate and ambitious. They recognise that there are weaknesses in practice that need to be addressed and they aspire to improve.

## **Safeguarding**

The arrangements for safeguarding are not effective.

Not all those acting on the playscheme management committee are known to Ofsted. This means they are not fully vetted for their roles. That said, managers who run the provision day-to-day and all staff are suitably vetted. The environment is secure, and during drop and collection times, the playscheme entrance door is always manned. However, children are not always supervised well in all areas within the playscheme. Managers are trained in the lead safeguarding roles and they have a clear understanding of their responsibility to identify and manage child protection concerns. However, despite routine safeguarding training, staff knowledge in this area is lacking and they cannot confidently explain the playscheme child protection procedures.

## What does the setting need to do to improve?

Kings Heath Playcare registered in 1995. The playscheme employs 18 members of staff. Of these, 11 holds relevant childcare qualifications at level 2 or 3. The playscheme operates all year round from Monday to Friday, term time only. Sessions are from 7.45am to 9am and 3.15pm to 6pm. The playscheme also operates from Monday to Friday, 8am to 6pm, during school holidays, with the exception of the Christmas period.

- The inspector looked at relevant documentation, records and policies. She also checked evidence of the suitability of the committee members and all managers and staff working in the playscheme.
- The inspector spoke to children and parents during the inspection and took account of their views.
