What is it like to attend this early years setting?

The provision is good

The childminder provides a warm, welcoming and friendly environment where all children feel safe and secure. Children form positive relationships with the childminder and each other. They behave in ways typical for their age and stage of development. The childminder successfully teaches children about rules and behaviour expectations. Children play cooperatively together, take turns and are kind to each other.

Overall, the childminder has high expectations for every child in her care and knows the children well. She works together with parents and other professionals involved to help each child to progress and to close any gaps identified in their learning and development. The childminder plans activities based on children's current interests and ensures these are age-appropriate. She regularly checks that children are still interested and able to continue in the way the activity is set up for them. For example, when youngest children stand at the table while painting, she checks if they want to continue their painting activity on the floor.

The childminder ensures children have enough opportunities to develop their physical skills. For example, she regularly takes them to the local parks and centres where they can safely take risks and use appropriate climbing equipment. This also extends children's curiosity and knowledge about their local community.

What does the early years setting do well and what does it need to do better?

- The childminder has worked hard to address all previous actions and recommendations from her last inspection. She has attended a number of courses and completed her own online research to meet all the requirements and to improve the quality of education and care provided. The childminder regularly reflects on her practice and ensures her house is safe and secure place for children.
- The childminder ensures children are curious and have stimulating opportunities to build on their current skills and abilities, to succeed in their future learning. She ensures children develop a love of books and reading, and she regularly reads to them. Children have their favourite books and know how to access these independently. The childminder successfully extends younger children's vocabulary and uses examples during their play to explain the meaning of new words. For example, when youngest children explore paint, they learn that paint is liquid and can drip if they hold the paintbrush high. The childminder clearly and slowly repeats new words so children can remember them. She uses good questions to stimulate older children. However, occasionally, the childminder does not give children enough time to think before answering for them or before asking them the next question.



- Children enjoy playing with toys that capture their interests, such as small-world figures in the playhouse and building blocks. The childminder skilfully incorporates children's own experiences in the play with their favourite toys to teach them about life skills. For example, when children play with small figures on a toy slide, she reminds them how they use the slide themselves. The childminder explains how to use it safely and why this is important. However, at times, she misses opportunities to extend children's early mathematical skills further during activities and discussions they have throughout the day.
- The childminder ensures children learn about their personal hygiene and living a healthy lifestyle. For example, children wash their hands after their nappy changing routines and before mealtimes. The childminder monitors how they wash their hands and explains about germs.
- All children make good progress from their starting points. The childminder knows what children can do when they start with her and closely monitors their progress through her own observations. She ensures that she completes the required progress check for children aged between two and three years, in time for their health review, and shares this with parents. The childminder successfully works together with parents and other professionals involved to help children achieve their next steps. Parents report that she regularly updates them about their child's day and achievements. They are happy with the services provided and the progress their children make.

Safeguarding

The arrangements for safeguarding are effective.

The childminder has good knowledge and understanding of how to safeguard children. She knows how to identify any potential child protection issues and the correct procedures to follow, including if an allegation was made against her. The childminder ensures that she regularly updates her safeguarding knowledge by attending relevant training courses. She ensures that her policy is in line with the local children safeguarding board procedures and has a list of relevant agencies to contact. The childminder confidently assesses risks both in her home and while on outings. She knows how to take effective action to ensure children's safety and well-being.

What does the setting need to do to improve?

To further improve the quality of the early years provision, the provider should:

- allow children more time to think and respond to questions before answering for them or asking another question
- provide more opportunities to enhance children's early mathematical skills.
