What is it like to attend this early years setting?

The provision is outstanding

Children thrive at this warm and friendly nursery. Staff create a very safe, nurturing environment where children thoroughly enjoy playing and learning. They have high expectations of what children can do and achieve. Babies play in a calm and serene setting where lights are dimmed, or music is played softly to create a real sense of tranquility. All children are extremely happy and settled.

Children behave very well. They learn in a peaceful, harmonious setting. Children show kindness, friendship and support to each other. They are polite, well mannered and give a warm welcome to visitors. Children learn how to express their feelings exceptionally well. Older children have an area of the room where they can relax and unwind when the need arises. They can use this cosy area to take time to reflect on their behaviour and consider how others might be feeling.

Toddlers and older children are excited and motivated. They choose what and how they are going to learn through play, exploration and music. Children enjoy frequent visits to the outdoor or forest school areas. Staff are highly skilled at nurturing children's imaginations. For example, they create video recordings of fairies and dragons in the forest school. Children are inspired to develop the area for the fairies to live in. They are soon making beds, baths and houses out of clay and talking enthusiastically about what the fairies might need.

What does the early years setting do well and what does it need to do better?

- Managers have an accurate view of the nursery. Staff use a parents' forum and children's committee to gain all users' views to drive standards even higher. Staff enjoy working at the nursery. They value the strong team work and training opportunities that help them to sustain such strong practice. Together, they maintain an outstanding provision which provides a consistently wonderful education for all.
- Learning is highly active, magical and fun. Staff implement an ambitious curriculum to help children achieve at the highest level. All staff unite in their desire to provide children with the best possible start to their education. Staff know exactly what each child needs to know before they move on to more difficult learning. They plan a vast range of interesting and exciting activities that are closely linked to children's current interests. As a result, children make outstanding progress in their learning and development.
- Staff help children to develop their literacy skills and a love of reading from a young age. Babies enjoy looking at picture and board books with staff. Toddlers select their favourite books, turn the pages carefully and point to the pictures. Children can take books and activities home to share with their family. Parents are invited into the nursery to read and enjoy stories with children.



- A strong focus on communication and language is evident throughout the nursery. Babies make sounds, babble and utter first words with great confidence. Older children engage in conversations, discuss ideas and negotiate expertly.
- Children know the routines exceptionally well and develop strong independence. For example, during lunchtimes, children help to set the table. They count out how many knives and forks they need. Children sit calmly and serve their own meals. They interact companionably with their friends and members of staff.
- Staff place a high priority on helping children to develop healthy eating habits. The dedicated nursery cook is a real asset to the overall provision. She provides a wealth of delicious and nutritious meals and snacks which children thoroughly enjoy. In addition, she leads cooking sessions for pre-school children where they learn how to prepare and cook their own meals.
- Partnerships with parents are exceptional. Staff use a range of successful strategies to involve parents in their child's learning. Parents use an online system to access their child's learning records at any time. Staff talk to parents daily and share feedback notes for the youngest children. Parents are regularly invited into the setting to join in with activities or to learn new skills themselves. For example, they benefit from attending first-aid skills training at the nursery. Parents are highly complimentary about the care their children receive. They comment that they are 'blown away' by the quality of the care and that their children love attending.
- Staff provide a range of activities to help children learn about the world around them. They invite parents in to talk to children about the different occupations they have. Staff carry out home visits to new families to help them get to know each other. They teach children about different religions or family backgrounds to help children develop respect and tolerance for different ways of life.

Safeguarding

The arrangements for safeguarding are effective.

The safety of children is paramount. Clear policies and procedures guide staff. Well-trained staff know what to do if they are worried about a child. Children learn in a safe and secure environment. Leaders are vigilant and work well with other agencies to support children and families. They act quickly if they have concerns. Children understand how to manage risks and take responsibility for their own safety. They can use real tools competently and act responsibly while sitting around an open fire.

Footsteps Nursery Canwell registered in 2012 and is one of a number of settings owned by Footsteps Day Nurseries Ltd. The nursery is open Monday to Friday from 7.30am to 6.30pm, all year round. There are 21 members of staff who work directly with the children, 15 of whom hold qualifications at level 2 or above. The nursery provides funded early education for two-, three- and four-year-old children.
