Summary of key findings

This provision meets requirements

- Staff are able to demonstrate a good awareness of how to plan and support early years children in the breakfast and after-school club. They have strategies in place to enable children to settle quickly. These include finding out about the children's needs and likes from parents and the school prior to the child starting, and on a daily basis as they move between the school and club.
- Staff provide opportunities for children to play and relax in the large and wellequipped inside and outside environments. Equipment and the play spaces are well maintained and cared for. Staff talk about the importance of the range and quality of equipment and how they seek children's views.
- Staff have high expectations of children to cooperate and take turns. Clear rules for safe and enjoyable play are well established for older children and would be adapted to meet the needs of early years children. For example, restricting time on the computer and games and not disturbing others during their time at these activities.
- Staff can demonstrate how they support children to be independent in making choices about activities and looking after themselves. Health and well-being are promoted through their healthy food choices and access to exercise and fresh air.
- Some parents have used the club over many years and talk about the wide range of activities and the support from the staff. They comment about how their children love attending and often play a game of hiding away when it is time to be collected. Staff have established strong relationships with parents and take time to discuss their children's session with them or pass on information from school.
- The manager and her deputy gather the views of their current group of children and parents to try to continuously improve on what they offer. They attend training to develop their skills and are well supported by the committee.
- Staff prioritise safety and supervision of activities. Risk assessments and safeguarding policies are detailed and clear. Premises are secure and systems are in place to share safeguarding expectations with parents and visitors.
- The manager and her deputy have completed a range of safeguarding training. They have a secure understanding of what might cause a concern and the procedures they need to follow to keep children safe.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
