# **Summary of key findings**

#### This provision meets requirements

- The manager is keen to encourage children to develop their independence and make choices for themselves. For example, she intends to continue her practice of allowing children to plan their own activities and menus.
- Children have access to a large, exciting outside provision. The manager understands how outdoor play has a positive effect on children's physical development. She plans to provide a wide variety of activities that will suit all ages and stages of development.
- The manager consistently evaluates herself and the club. She listens to children, staff, parents, the school and the local authority for ideas and suggestions. She reflects on things that work well and things that could be improved. The manager develops plans to implement new initiatives for the next time the club will operate. For example, she intends to use walkie-talkies next year to improve staff's communication when they are outdoors.
- The manager places great importance on building strong partnerships with parents and the school. She has gathered information from them about children's interests and needs. The manager understands that this can help children settle well and support them to feel safe and secure.
- The manager has a clear understanding of how to keep children safe. She knows how to identify signs and symptoms of abuse and how to report any concerns she may have about a child or adult. The manager demonstrates a good knowledge of safer recruitment and procedures for checking the ongoing suitability of staff. The manager has sound procedures in place to ensure that staff keep their safeguarding knowledge up to date.
- The manager is keen to ensure that she offers an inclusive service. For example, she intends to encourage children to share information about their own cultures and backgrounds, such as their traditional dress and the foods they eat. The manager will continue to work closely with other professionals to support those children with special educational needs and/or disabilities.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
