## **This inspection**

### **The effectiveness of the holiday scheme and the progress and experiences of children and young people since the most recent full inspection**

This holiday scheme has not yet had a full inspection. At this interim inspection the holiday scheme was 'not judged'.

As the Lambourne End residential holiday scheme has not operated since registration and no children have received a short break, it has not been possible to conduct an inspection of the scheme in action.

The residential holiday scheme may operate at any premises defined by the scheme as safe and suitable. Consequently, it has not been appropriate to review the suitability of a single premises. It was therefore agreed that the inspection would consist of a telephone interview with the registered manager but with no judgement made.

The registered manager confirmed that no children have received a short holiday break through this scheme. The registered manager has confirmed that the scheme will not be operational until at least April 2020.

In the event of operating a holiday scheme, the registered manager is aware of his responsibilities to ensure that the scheme is well planned and properly staffed and organised.

The registered manager is aware of the requirement to inform Ofsted of any impending schemes for the following year.
