### What is it like to attend this early years setting?

#### The provision is outstanding

The childminder provides an exceedingly warm and welcoming home environment where children demonstrate they feel safe and secure. Children have forged close attachments with the childminder and are extremely happy in his care. They are independent learners who display high levels of confidence during their play. The childminder places a strong focus on mathematical development. Children have numerous opportunities to explore numbers in the environment. They learn to predict how many bottles are left as they sing, '10 green bottles'. In addition, they learn mathematical language, such as 'more' and 'less', as they serve themselves fruit at snack times. Children are kind and polite. They pass cups and spoons to each other, and demonstrate sheer contentment. Children show exceptional behaviour because they thrive on the praise they receive from the attentive childminder.

Children are extremely motivated and show determination to compete tasks, such as when they place features on their 'snowman's face'. They cherish spending time with the childminder and invite him into the book area to snuggle down and look at books together. The childminder makes excellent use of funding, such as purchasing additional toys to support outdoor play. This has contributed to the wealth of opportunities for children to be able to play outside in all weathers.

## What does the early years setting do well and what does it need to do better?

- The childminder uses his extensive knowledge to promote children's individual learning. He expertly identifies children's unique next steps in learning. He meticulously plans the children's day with clear learning intentions for what they need to achieve next. The childminder has focused strongly on developing his knowledge and skills ready for changes in early years practice.
- The childminder creates an excellent sense of excitement. He gives each child an ice cube and tells them to take care of it. Children giggle with delight when he later questions where it has gone and asks children how it disappeared.
- The childminder's excellent teaching skills highly motivate children. They are captivated as the childminder reads a story about a snowman. For example, when exploring the illustrations within the book, children are mesmerised by the melting snowman when he stands too close to the fire. The childminder skilfully uses probing questions to develop children's thinking skills. Children enthusiastically respond, 'He is standing too close to the fire and melting.' This supports their excellent developing skills in literacy.
- The childminder offers an extensive range of imaginative learning experiences. For example, young children explore what types of clothing are worn to keep warm in cold weather. They act out play scenarios to include dressing up as a snowman, which supports their developing independence in dressing and



- undressing. They demonstrate enjoyment as they put on hats and scarfs and dance like snowmen.
- Children make exceptional progress with their speech and language skills. The childminder provides a rich learning environment where children have many excellent opportunities to build on their developing vocabulary. Young children confidently name carrots, twigs, stones and buttons as they discuss the features of the snowman they are creating.
- The childminder is highly successful in promoting children's understanding of the wider world. He takes spontaneous learning opportunities as they present themselves. For example, when walking along the river bank, children become fascinated with the repairs being carried out on the gates of the lock. They show a high level of interest as the carpenters explain what they are doing and are extremely excited to be invited back to see the end results.
- Partnerships with parents are highly effective. Parents receive regular newsletters on planned activities and outings so remain informed in their children's learning. In addition, the childminder shares children's next steps in learning and areas of focus so parents can readily support children's learning at home. Parents comment that they feel fortunate to have such an exceptional childminder caring for their children and who their children adore.
- All children's needs are exceedingly well met because the childminder has highly effective partnerships with external agencies. This includes those children for whom the childminder receives additional funding. This has contributed to children making exceptional progress in their learning.

### **Safeguarding**

The arrangements for safeguarding are effective.

The childminder has an extensive knowledge and understanding of safeguarding and child protection, including the wider aspects of safeguarding, such as internet safety. He undertakes regular training to help ensure his safeguarding knowledge remains current. The childminder is confident in following the referral process should he have any concerns about a child's welfare. The childminder's robust and stringent safety procedures keep children safe in the home and when out in the local environment. He teaches children how to manage risks without making them fearful. For example, they know how to keep safe when walking along the river bank.
