Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 7a and 7b and 32(1)(c)

- All of the standards in this part were met at the school's last standard inspection in May 2018.
- The proprietor, governors and leaders have not made sure that pupils' welfare is ensured. Currently, only the headteacher has completed the necessary training to be the designated safeguarding lead (DSL). The inspector saw evidence that two deputy DSLs are due to be trained in December 2019. The governors have not completed recent safeguarding training so are not familiar with their statutory responsibilities. As a result, the school has limited capacity to ensure that up-to-date policies and procedures are in place.
- Staff have completed annual, online safeguarding training. They know what to do if pupils are at risk of harm. However, the school's safeguarding policy, available on the school's website, has not been updated. It does not have regard for the most recent guidance issued by the Secretary of State. As a result, staff are not provided with guidance on how they are expected to manage specific risks in school such as peer-on-peer abuse, sexual violence and harassment, and sexting. There is no clear policy on how new staff will be inducted into the school.
- Staff are providing some effective support for vulnerable pupils. Leaders identify local and individual risks to pupils. They work with external agencies to make sure that pupils get the support they need. Pupils to whom the inspector spoke said that they felt safe at school. The small number of parents spoken to agreed.
- These standards are not met.

Paragraphs 11, 12, 16, 16(a) and 16(b)

- The proprietor and leaders have not ensured that their health and safety policy has been put into practice. They have not checked to make sure that daily and weekly health and safety checks are carried out. Records show that these checks have not happened for over a year.
- They have not addressed actions that were identified in a fire risk assessment in 2018. A fire exit continues to be partially blocked. Leaders and pupils are not clear



about fire assembly points, which are currently somewhere in a public car park at the rear of the building. Door closers have not been fitted on all fire doors. The inspector found that one fire door was swollen by rain and was very difficult to open and close. Fire exits have not been suitably labelled. Only one brief record of a fire drill has been completed. Leaders were unable to provide any evidence of previous drills being carried out.

- Leaders have ensured that they put their risk assessment policy into practice for some activities, including off-site physical education (PE) at the local gym. However, they have not assessed the risks for evacuating pupils from the building on to a public car park. Assembly points have not been clearly marked.
- These standards are not met.

Paragraph 14

- Leaders have ensured that pupils are appropriately supervised throughout the school day, including at breaktimes and lunchtimes. Additional staff mentors are on hand to offer help to pupils who need it, or who need to take a break from learning.
- This standard is met.
- Not all the paragraphs in this part are likely to continue to be met if the material change is implemented.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2), 18(2)(a), 18(2)(b), 18(2(c), 18(2)(c)(i), 18(2)(c)(ii), 18(2)(c)(iii), 18(2)(c)(iii), 18(2)(d), 18(2)(e), 18(3), 20(6), 20(6)(a), 20(6)(a)(i), 20(6)(a)(ii), 20(6)(b)(iii), 20(6)(b)(iii), 20(6)(c), 21(1), 21(3), 21(3)(a), 21(3)(a)(i), 21(3)(a)(i), 21(3)(a)(i), 21(3)(a)(v), 21(3)(a)(v), 21(3)(a)(vi), 21(3)(a)(vii), 21(

- All of the standards in this part were met at the school's last standard inspection in May 2018.
- Leaders are not making sure that the school's single central record (SCR) is kept up to date. A few adults are missing from the record. This means that suitable pre-employment checks have not been carried out. Until the day of the inspection, the appropriate section 128 checks on adults in management positions had not been completed. Recently completed checks on new staff have not been recorded.
- Leaders could not assure the inspector that they have checked that new staff are fit to begin work at the school. Leaders are not checking potential new staff's application forms well enough for any gaps in employment.
- These standards are not met.

Paragraphs 21(2) and 21(3)(a)(iii)

- The school maintains its SCR in electronic form. All section 128 checks have now been completed, with no concerns about individuals identified.
- These standards are met.
- Not all of the paragraphs in this part are likely to continue to be met if the material change is implemented.



Part 5. Premises of and accommodation at schools

Paragraphs 24(1), 24(1)(b), 25, 28(1), 28(1)(b), 28(1)(c), 28(1)(d), 29(1) and 29(1)(b)

- All the standards in this part were met at the school's last standard inspection in May 2018.
- The accommodation for the medical examination of pupils is in a poor state. The floor appears to have been damaged by water. As a result, the surface is not level and is a tripping hazard. The mattress did not have suitable covering in the event of a pupil requiring first aid. The tank which supplies water to the portable sink is empty. None of the bathroom facilities have a supply of hot water.
- Pupils have access to a supply of drinking water in kitchen areas. However, water supplies for drinking are not labelled.
- The small outdoor space for pupils is unsuitable. It is strewn with litter. Leaders allow 16-year-old pupils to smoke in this area.
- These standards are not met.

Paragraphs 23(1), 23(1)(a), 23(1)(b), 23(1)(c), 24(1)(a), 24(2), 26, 27, 27(a), 27(b), 28(1)(a), 28(2), 28(2)(a), 28(2)(b) and 29(1)(a)

- Suitable toilet and changing facilities are provided for pupils in the school. Pupils are taught in a suite of classrooms, which have suitable lighting and acoustics. Pupils take part in PE activities at a local venue.
- These standards are met.
- Not all of the paragraphs in this part are likely to continue to be met if the material change is implemented.

Part 6. Provision of information

Paragraphs 32(2), 32(2)(b)(i), 32(2)(c), 32(3)(d), 32(3)(e) and 32(3)(f)

- All the standards in this part were met at the school's last standard inspection in May 2018.
- Checks to part 6 of the independent school standards were not in the original scope of the inspection. However, during the inspection, the lead inspector identified several unmet standards regarding information that should be published on the school's website.
- The name of the proprietor and their contact details are not listed on the website. There are no details for the chair of governors. The proprietor reported that two governors share this role, but only one is listed.
- The school has not published its first aid policy. It has not reported on the number of complaints made about the school in the previous year. Leaders have not provided information about the pupils' academic performance in the last year.
- These standards are not met.
- The paragraphs in this part are currently unmet and are therefore unlikely to continue to be met if the requested material change is implemented.



Part 8. Quality of leadership in and management of schools *Paragraphs 34(1), 34(1)(a), 34(1)(b) and 34(1)(c)*

- All of the standards in this part were met at the school's last standard inspection in May 2018.
- The DfE has not been notified about some of the changes to the school.
- While both the proprietor and the chair of governors are supportive of leaders and the school, they have not ensured that all of the independent school standards are being met consistently and continually. There are weaknesses in safeguarding and recruitment checks. Leaders and governors have not made sure that the school's website is kept updated.
- Governors have not had recent safeguarding training. The chair of governors recognises that this needs to be updated. This will enable governors to ensure that they are familiar with, and able to carry out, their statutory duties.
- The proprietor and governors acknowledge that the newly appointed headteacher has not received enough support so that he can ensure that the independent school standards are consistently and continually met.
- While staff aim to keep pupils safe every day, and pupils say that they are kept safe, wider safeguarding concerns remain. Leaders have not ensured that health and safety standards have been maintained. As a result, pupils are at potential risk of harm. During the inspection, leaders began to take action to address these standards to ensure that pupils are not at immediate risk of harm.
- These standards are not met.
- The paragraphs in this part are currently unmet and are therefore unlikely to continue to be met if the requested material change is implemented.

The school's application to make a material change to its registration

Leaders have not given sufficient consideration to accommodating up to 55 additional pupils. Many standards are not met at present. These standards are unlikely to be met in the future unless substantial improvements are made.

Requirements unlikely to be met if the material change relating to the school provision is implemented

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- The information held on the government's 'get information about schools' (GIAS) website is not accurate. There is no proprietor listed. The proprietor continues to be absent due to ill health and this role has been taken on by his brother in an acting capacity.
- The school caters for pupils aged between 12 and 16 years, but the website states that it caters for pupils up to the age of 18 years. A few pupils have an education, health and care plan but GIAS does not reflect this.
- The school has recently appointed a new headteacher. The school has had two acting



headteachers since the previous headteacher left due to ill health.

- The school opened in 2017. It relocated to its current site in September 2018. It caters for pupils who are at risk of being, or who have been, permanently excluded from mainstream schools.
- The school received its first standard inspection in May 2018. It was judged to be good. An additional material change inspection took place in September 2018, as the school had applied to the DfE to extend its age range.
- The school uses two alternative providers: Dare2Dream Foundation, Newton Road, Nuneaton CV11 4HG and Worknlearn, 27 Frederick Street, Jewellery Quarter, Birmingham B1 3HH.
- The school does not have a religious ethos.



Information about this inspection

- The Department for Education (DfE) commissioned this inspection because of complaints received about the welfare, health and safety of pupils. They asked Ofsted to check on safeguarding arrangements and the quality of leadership and management in the school. The lead inspector concluded that the issues raised in the complaints were dealt with appropriately. However, the inspection revealed wider concerns about safeguarding.
- The one-day inspection was conducted without notice.
- The DfE asked for additional standards to be checked because the school has applied for a material change. It plans to admit up to 100 pupils to the school. The school is unlikely to meet the range of independent school standards if the material change is implemented.
- The inspector met with the headteacher, deputy headteacher, the proprietor and the chair of governors. She spoke to staff and pupils informally during the inspection. The inspector met with three parents.
- The inspector toured the premises, accompanied by the headteacher.
- The inspector reviewed a range of documentation, including: safeguarding policies and related information; the school's single central record and a sample of personnel files; behaviour records; and a range of health and safety documents, including those relating to fire safety. She checked a range of information available via the school's website.
