Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraph 7, 7(a)–(b)

- The proprietor has not ensured that the school's safeguarding policy complies with the latest guidance issued by the Secretary of State. The requirements set out in both 'Keeping children safe in education', 2019, and the statutory arrangements for children missing in education have not been followed for absent pupils.
- The roles and responsibilities for safeguarding are not clearly defined. The designated leader for safeguarding has not yet had the training she needs.
- However, the proprietor has taken action to train staff in basic awareness and procedures. Further staff training is planned to increase awareness about radicalisation and extremism.
- Leaders were unable to provide a safer recruitment policy or defined procedure. For recently appointed staff, checks are missing and there are no risk assessments in place.
- The proprietor has not ensured that there is a suitably qualified designated teacher for children looked after by the local authority. This is of particular importance in this setting, where the majority of pupils are in the sole or joint care of local authorities.
- The standard in this paragraph is not met.

Paragraph 9

- The behaviour policy has not been updated since the standard inspection in November 2019. The policy sets out that the school's chosen approach does not use sanctions.
- When incidents of poor behaviour do occur, staff give insufficient thought to the triggers or underlying reasons. Although the behaviour management system records the nature of pupils' misbehaviour and the observations leading up to each incident, actions to support pupils' behaviour are not bringing about improvements. Consequently, disruptive behaviours and swearing persist.
- The standard in this paragraph is not met.

Paragraphs 11, 12 and 16



- The health and safety policy has not been updated since the previous standard inspection. The fire safety equipment checks carried out on the day of this inspection, and the day before, revealed several faults. The full range of checks required have not been completed and the record of the checks done lacks the necessary detail.
- The effectiveness of pupils' personal emergency evacuation plans, which was raised at the previous inspection, has not been reviewed.
- The risk assessment policy has not been updated. Risk assessments for off-site activities, such as rock climbing, horse riding and trampolining are generic and do not consider the particular needs of individual pupils.
- The standards in these paragraphs are not met.

Paragraph 14

- The number of pupils attending the school has reduced since the inspection in November 2019. However, the number of staff has been maintained. Consequently, there are high staff to pupil ratios and pupils are effectively supervised throughout the school day.
- The standard in this paragraph is met.

Paragraph 15

- Leaders have not maintained an admissions register that meets the requirements set out in the Education (Pupil Registration) (England) Regulations 2006. Information about the parents and carers of each pupil is incomplete. Where pupils have moved away from the school, the name of the new school and date started, or intended to start, is not recorded. Amendments to the register do not include the original entry, the reason why the amendment was made, the date the amendment was made and the name and position of the person making the change.
- The standard in this paragraph is not met.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2), 18(2)(a)–(e), 18(3), 21(3) and 21(3)(a)–(b)

- Leaders have not checked that all teaching staff are not prohibited from teaching. For one recently appointed member of staff, none of the necessary checks are recorded on the single central register.
- The standards relating to suitability of staff to work with pupils are not met.

Part 5. Premises of and accommodation at schools

Paragraph 25

- The deficiencies of the fire safety arrangements and other missing safety checks mean that the health, safety and welfare of pupils on the premises cannot be assured.
- The standard in this paragraph is not met.



Part 8. Quality of leadership in and management of schools

Paragraph 34(1), 34(1)(a)–(c)

- The proprietor and school leaders have not had the training they need to improve their understanding of the independent school standards. Consequently, they do not demonstrate that they have gained the knowledge they need to effect the necessary changes and monitor their implementation.
- All bar one of the standards checked during this emergency inspection are unmet.
- The standard in this part is not met.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. Not all of the standards and associated requirements were checked during this inspection.

- Abbey Rose School is operated by Orbis Education and Care Limited. The proprietor also operates four schools in Wales.
- The school was registered and opened on 14 March 2019. The first standard inspection of the school was carried out in November 2019, when the school was judged to be

inadequate.

- The school does not use any alternative provision. It does not use any off-site unit.
- There are currently no pupils in the sixth-form provision.
- The school offers education for pupils with a formal diagnosis of autistic spectrum disorder or associated needs. All have an education, health and care plan or are about to have one. All are placed at the school by their respective local authority.



Information about this inspection

- This emergency inspection was carried out at the request of the registration authority for independent schools as a result of concerns regarding pupils' welfare and safety.
- The inspection was carried out with no notice.
- The inspection focused on the pupils' health, safety and welfare, safeguarding arrangements, school leadership and governance.
- The inspector met with the interim headteacher, who is also the designated safeguarding lead. The inspector also met with the newly appointed headteacher, the deputy designated safeguarding lead, members of staff and the head of business development. The inspector spoke with one of the directors who represents the proprietor.
- The inspector analysed a range of documentation provided by the school.
