#### What is it like to attend this early years setting?

#### This provision does not meet requirements

The provider and manager do not have a good enough overview of the setting, to ensure that all staff are confident within all areas of their role. The arrangement for the supervision of staff is not effective in identifying staff's weaknesses. Some staff do not have a secure safeguarding knowledge. That said, the provider knows his responsibilities and is beginning to implement more rigorous procedures, to improve the organisation of the club. Managers and staff complete risk assessments of all areas in use. Staff conduct daily opening checks to ensure the resources and equipment are suitable. However, staff have not yet identified any risk associated with children playing on the school field. That said, children are supervised well during their time at the club. Children arrive at club happy and confident. They settle quickly to a range of activities. Children play imaginatively with their friends and chat happily away. They enjoy drawing pictures and making Christmas decorations. All children engage in activities that hold their interest. Staff give children choices about what they would like to do. They provide daily physical activities to help children to let off steam after a busy day at school. Children behave well and are considerate to their friends. They show respect for others and listen well to each other's views and opinions.

# What does the early years setting do well and what does it need to do better?

- The provider ensures that new staff undergo safer recruitment checks. A more detailed induction programme has recently been introduced. However, this has not yet been implemented effectively. Consequently, induction processes are not always thorough enough, to ensure new staff gain the required knowledge quickly.
- Due to the deployment of the leadership team, the manager is not always present in the rooms catering for the youngest children. Although the deputy manager is present and is knowledgeable and confident to take the manager's lead, she is not involved in the supervision arrangements. Therefore, the manager does not have a good enough overview and the supervision arrangements are not consistently effective for all staff. This means that some staff do not have the knowledge and skills they require to fulfil their roles.
- The provider has not ensured that all staff have completed up-to-date safeguarding training. As a result, some staff's knowledge of child protection issues and wider safeguarding concerns, including the 'Prevent' duty, is not strong enough. This does not help to keep children fully protected from different types of harm.
- All staff complete regular checks within the club to minimise risks to children. Staff supervise children well. However, there are times when children use the school field, and the risks to children being able to leave the premises



- unsupervised or unauthorised people gaining access have not been fully considered. This does not ensure children are kept safe at all times.
- Children develop good hygiene practices as they know to wash their hands before tea and after going to the toilet. They enjoy hot food which is prepared daily. However, there is scope for the club to provide a more healthy diet to help children to learn about leading a healthy lifestyle. Children have good opportunities to develop their physical skills as they play a range of games, such as 'Simon says' and dodge ball. Children develop their independence as they come into the club and hang their coats and bags up, and make choices about what they want to play with.
- Partnerships with the school and parents are good. Information is regularly shared to ensure suitable communication between the school, club and home. Parents' and children's views are listened to. The club has introduced worry and suggestion boxes, which staff say have been a success with giving children more of a voice and helping them to talk about how they are feeling.
- Staff are positive role models. Their warm interactions help children to settle quickly and to make friends. Children play well together. Younger children join in with older children's games, and they share and take turns effectively. All children behave well, and they fully understand expectations and boundaries.

### **Safeguarding**

The arrangements for safeguarding are not effective.

All staff are suitably vetted for their roles. Most areas of the environment are secure, and during drop-off an collection times there are rigorous procedures in place. However, there are times during outdoor play activities when children are in areas that are not secure, and the provider and manager have not considered all of the risks associated with this. The manager and deputy manager are the designated safeguarding leads. They have attended training and have a clear understanding of their responsibility to identify and manage child protection concerns. However, not all staff have received routine safeguarding training and, despite regular discussions during team meetings, some staff lack knowledge in this area. They are not confident with being alert to issues of concern in a child's life at home or elsewhere. This means children's safety and welfare are not given the highest regard.

# What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
