Overall outcome

The school does not meet the independent school standards relevant to the material change. The material change has already been implemented.

Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 11, 12, 14 and 16

- Safeguarding leaders have recently completed enhanced training. They have a secure understanding of how to keep pupils as safe from harm as possible, including in light of the latest statutory guidance. Leaders manage concerns well. However, the school's child protection policy does not reflect the latest guidance issued by the Secretary of State. In addition, the single central register of vetting checks is not compliant, as outlined in part 4.
- The school's health and safety and risk assessment policies are suitable. However, there are no written risk assessments for either of the new premises. Leaders ensure that daily safety risk assessment checklists are completed, but these lack rigour. Of greatest concern is fire safety, especially at the Golders Green Road premises. Leaders have not commissioned external fire safety risk assessments. Instead, they have written internal fire safety risk assessments, which lack credibility. For example, the Golders Green Road site's risk assessment states that there is no need for fire safety doors, and that there is no requirement for emergency lighting in the building. This is not the case. Certification from September 2019 confirms that emergency lighting is present in the premises but that some of it is not working. This has not been fixed and the required monthly checks have not been carried out. The school is not compliant with the Regulatory Reform (Fire Safety) Order 2005.
- There is likely to be an appropriate deployment of staff to ensure that pupils are safely supervised. Children in the early years are supervised in line with the requirements of the early years foundation stage. Pupils of compulsory school age are appropriately supervised at a ratio of approximately one adult to eight pupils.
- Some of the independent school standards checked in this part are not met, as listed in the annex to this report.



Part 4. Suitability of staff, supply staff, and proprietors

All paragraphs

- The single central register (SCR) of checks on staff, agency staff, governors and proprietors is not compliant.
- Prohibition from teaching checks have not been completed on all the required staff; some are wrongly marked as 'processing'.
- Barred list checks are not identified on the SCR.
- One of the proprietors and none of the governors have been checked and included on the SCR.
- There were some misunderstandings about the difference between 'right to work in the United Kingdom' and 'additional checks for those who have lived and/or worked abroad' checks, which were clarified during the inspection.
- Leaders have incorrectly continued to check whether staff are 'disqualified by association', a practice that leaders ceased during the inspection.
- Some staff members' qualifications required to meet the requirements of the early years foundation stage have not been listed on the SCR.
- Some of the independent school standards checked in this part are not met, as listed in the annex to this report.

Part 5. Premises of and accommodation at schools

All paragraphs

- The school has already relocated to its new main premises at 37 Elmcroft Crescent, London NW11 9TB, which is where pre-nursery children attend. These premises have been fully refurbished and currently accommodate 58 children. They are likely to be able to accommodate a maximum of 70 children.
- The Elmcroft Crescent premises are clean, safe and well maintained. Works to further improve the suitable toilet and washing facilities are underway. The two large classroom spaces are modern, bright, spacious and well equipped. There is suitable outdoor space for play and physical development. Hot water supplies are safely regulated, drinking water is labelled as such and provided to pupils in jugs. The acoustic conditions, sound insulation and internal and external lighting are suitable throughout the premises. However, there is not a suitable medical room facility. The current arrangement to draw curtains on a teaching and play area that does not include a washing facility is not appropriate.
- All other pupils now attend the new temporary premises at 285 Golders Green Road, London NW11 9JE. There are currently 45 pupils attending these premises. It is the inspector's view that the premises are at capacity and that no further pupils should be admitted.
- The Golders Green Road premises, converted from their previous use as a hotel, have been made safer than they were when they were acquired, but are not suitable for long-term use as a school. The building includes five classrooms (previously hotel bedrooms), several toilets with washing facilities (previously hotel bathrooms), offices

and an area for pupils to eat their lunch.

- The acoustic conditions, sound insulation and internal and external lighting are suitable throughout the premises. However, there are multiple blown or missing lightbulbs, and dangling wires in some places where bulbs have not been replaced. Though these are not in pupils' reach, they reflect a lack of attention to detail in making the premises a pleasant place to work, learn and play.
- There is ample outdoor space in the large garden. However, there are some gaps in the fencing and the artificial lawn presents a tripping hazard. Staff told the inspector that the fire exit signage appears to be incorrect, as it leads to a locked gate. There are additional fire safety concerns about fire doors and emergency lighting, as identified in part 3.
- Labelled drinking water is available from taps throughout the building. It is not known whether the temperature of hot water supplies is safely regulated because there was no hot water supply and no heating in half of the building during the inspection. The lunch space in particular was unacceptably cold.
- There is no suitable medical room facility. The space presented does not include a washing facility, has the staff toilet facility within the room, and is set up entirely as an office, with an available camp bed. There is no space for the secure storage of medication.
- Some of the independent school standards checked in this part are not met, as listed in the annex to this report.

Part 6. Provision of information

Paragraph 32(1), 32(1)(c)

■ In the absence of a website, leaders ensure that a hard copy of the school's child protection policy is readily available to parents and visitors. As a result, this requirement is met.

Part 8. Quality of leadership in and management of schools

Paragraph 34

■ The change of the school's main premises has already taken place, and this inspection has identified unmet independent school standards. Additionally, leaders have not ensured that all the standards checked during this inspection – including the standard in this part – are likely to be met if the material change to increase the maximum number on roll is implemented at this time.

Information about this school

- Peninim is an independent primary day school in the London Borough of Barnet. It serves boys and girls in the pre-nursery, and girls only from ages three and above. Pupils are of Jewish Orthodox faith.
- The school's most recent inspection was a full standard inspection in November 2018, when its overall effectiveness was judged to require improvement, and all the independent school standards were judged to be met.
- Information about the school's proprietorship is currently incorrect on the website 'Get information about schools' (GIAS). The proprietor is Peninim Ltd. The chair of the proprietorial board is Isaac Brief. There are two other members of the proprietorial



body. The proprietors are now supported by a governing body.

- Since October 2019, the school has vacated the premises currently identified on GIAS. The pre-nursery now operates from the school's new main premises at 37 Elmcroft Crescent, London NW11 9TB. All other pupils attend the new temporary premises at 285 Golders Green Road, London NW11 9JE.
- The school's current registered capacity is 50 pupils. At the time of this inspection, 103 pupils were on roll.

Information about this inspection

- This first material change inspection was commissioned by the Department for Education to consider the school's application to increase its pupil numbers and change its main premises. The inspection was conducted with two days' notice.
- In light of the change in premises and the increase in number on roll from 50 to 103, the inspector was asked to consider whether the school continues to comply with some of the requirements in Parts 3, 4, 5, 6 and 8 of the independent school standards.
- In the absence of the substantive headteacher, the inspector met with the chair of the proprietorial body, the designated safeguarding leader and the head of secular education. The inspector toured both new premises and considered a range of relevant documentation, such as policies, risk assessments and fire safety information. He also checked the school's single central register of vetting checks.
- There were not enough recent responses on Ofsted Parent View to consider as part of this inspection.
