Summary of key findings

This provision meets requirements

- Leaders and staff understand their role in keeping children safe and protecting them from risk of harm. The provider implements safer recruitment procedures to ensure that all staff are suitable to work with children. Staff attend regular safeguarding training and demonstrate a secure understanding of the signs that might indicate a child may be at risk. They know the procedures to follow if they have concerns about a child's well-being.
- Leaders acknowledge the importance of reflecting on practice. They effectively review the provision and take positive steps to make improvements. They demonstrate a clear and ambitious vision to provide high-quality inclusive care to all children. For example, they have strong shared values, policies and practices in place.
- Staff recognise the importance of having high expectations of children's behaviour. They know how to support children to understand how their behaviour impacts on others. They have clear rules and boundaries.
- Leaders identify the significance of ensuring that there is a well-established system for key persons to help children to form attachments so that they feel safe and secure within the setting.
- Leaders and staff understand the importance of children being physically active, both inside and outdoors, to help develop children's overall physical and mental well-being.
- Leaders effectively engage with the staff and are aware of the main pressures on them. They are realistic in the way they manage staff, including their workload.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
