## What is it like to attend this early years setting?

#### This provision meets requirements

Children are at the heart of all decisions made about the club. Staff show a genuine interest in what children have to say. This reassures children and helps them to feel safe and included. Staff supervise children well, reminding children of expectations and boundaries. To encourage children to listen, an adult will call out, 'Super,' and the children respond with an enthusiastic, 'Pirates.' This not only gets their attention, but also helps them to develop a real sense of belonging. Staff are careful to notice how children are feeling, identifying when a child may need reassurance or extra support. As a result, children settle well and thoroughly enjoy their time at the club.

Children are keen to get involved in activities due to the high levels of enthusiasm demonstrated by all staff. There is an overwhelming sound of laughter and excitement throughout the play areas as children have fun in the games they play. Children behave well, motivated by the staff who notice their good behaviours and constantly provide encouragement and reward. Children state that they feel safe at the club and feel able to speak to staff if they are worried about anything. Staff are very friendly and encourage children to chat to them. For example, a member of staff sits with small groups of children as they have their snack, providing good opportunities for them to share any concerns.

# What does the early years setting do well and what does it need to do better?

- The club leader motivates and supports the staff team very well. Staff receive excellent support to ensure they fully understand their roles and responsibilities, such as through regular supervision meetings. As well as providing formal training, every opportunity is taken to remind them of policies and procedures and increase their understanding of their role. For example, as the staff walk to collect the children from school, they discuss their safeguarding policies to ensure they have a deep understanding of how to identify and respond to any concerns.
- Staff constantly reflect on the service they provide to children and families, with the intention of making it the best it can be. They complete daily evaluations on events and activities and seek feedback from parents and children. For example, at the beginning of each term, children contribute to the plans of activities and events and make suggestions about new equipment to be purchased. This ensures that children's preferences are represented well in the provision.
- Children are free to make choices in how they play, what they play with and where they play. For example, most children are keen to go to the park on the way home from school to engage in physical play activities outdoors. However, staff quickly arrange staffing to ensure that children who would prefer to play



indoors are able to do so.

- New systems to manage records and documentation mean that staff have easy and quick access to important information about children's individual needs to help ensure these are met.
- There is an emphasis on encouraging kindness within the club. Children recognise the need to be considerate and respectful to each other. They receive good support, through discussion, resources and activities, to learn about what makes them all unique.
- Staff support children well to keep healthy and develop physical skills. Water is easily accessible at all times, and children are reminded to have a drink when they return from their vigorous play at the park. Staff provide a healthy snack for children to select from, ensuring this reflects children's individual dietary needs as necessary.
- Children learn new skills and gain confidence and independence at the club. For example, children listen, watch and show sustained concentration as they learn a magic trick. They show exceptional pride as they share the trick with other adults and children.
- Good partnership working with parents and schools enables staff to have a clear understanding of children's needs. Early years children have dedicated staff to support them. These staff pay close attention to children's development and provide opportunities for children to build on skills they develop at school. This information is shared with parents through the online records to keep them well informed.

## Safeguarding

The arrangements for safeguarding are effective.

All staff demonstrate a very good understanding of procedures to keep children safe. They complete child protection training. Senior staff frequently check staff's knowledge through discussions to ensure they are clear about the procedures and their roles. Staff recruitment is thorough, and newly introduced systems for staff supervision include opportunities for staff to share well-being information, so that managers can assess staff's ongoing suitability. Staff give good consideration to safety. Consistent routines, on the walk back from school and in the park, help children to learn about how to keep themselves safe when out and about. For example, all children are reminded of the importance of looking and listening as they cross the road, even though a member of staff is stopping the traffic to allow them to cross.
