What is it like to attend this early years setting?

This provision meets requirements

Children quickly settle when they attend the club and enjoy choosing from a range of resources and activities. They are fully involved in making decisions in the club. For example, children are consulted about what they want at snack time and work together to create suggestions including soup and French bread. Staff build on children's understanding of how to lead a healthy lifestyle and make positive choices about what they eat. Children enjoy being physically active. They squeal with delight as they play chasing games and experiment with moving in new and exciting ways. However, some children would benefit from the chance to have some guieter time. Staff are skilled at challenging children during activities. For instance, children make up new rules in the games they play. Children's social skills are supported well. Children say that they enjoy making friends at the club. They behave well, are happy, and form good bonds with the friendly staff, who have a good sense of fun. Staff carefully create an inclusive atmosphere and provide additional support for children with special educational needs and/or disabilities. They keep children safe and support them, for instance, in putting resources away when they have finished using them so they do not become a hazard.

What does the early years setting do well and what does it need to do better?

- Staff consistently build on the learning children experience in school. For example, they support children in using their mathematical learning as they are asked to count the number of children attending the club. Staff provide games which encourage children to problem-solve and use their emerging literacy, for example, to read labels as they match pictures. Children are supported with well-directed praise which enables them to understand what they have achieved. Children are happy and enjoy attending the club.
- The manager consistently reflects on the service he provides for parents and children. He constantly creates new ways of obtaining children's views. For example, he has organised a children's council which enables children to request new resources which reflect their developing interests. Children's ideas and feedback are displayed in the club.
- Parents praise the manager and staff. They say that they are kept well informed about the activities their children participate in when they attend the club. Parents particularly highlight the flexibility the club offers and the ease with which they can book places. They say that the staff keep their children safe and work hard to build positive relationships with them and their children.
- Children talk about how they enjoy the different physical games offered, such as dodgeball. However, on occasion, younger children become tired after a busy day at school and are not always able to relax and engage in quieter activities, to support their emotional well-being even further.



- Staff say that their professional development is supported well. They talk about how they benefit from regular training and supervision. Staff regularly reflect on their own performance and use this effectively to identify how they would like to build on their skills and knowledge further.
- Children are encouraged to carry out simple tasks. There are clear routines in place which support children in understanding, for example, that they need to wash their hands after activities and before eating. They all join in and help clear the tables after snack time, and they tidy away their bags and coats when they arrive at the setting.
- Staff provide clear strategies to support children in understanding when they need to listen to instructions. Children respond well and, for instance, move calmly between activities. Staff support children in understanding the impact of their behaviour on others and help them to resolve minor conflicts quickly.
- Staff provide children with a range of opportunities to explore diversity and think about different cultures and religious festivals. Children enjoy a variety of craft activities and are able to practise the skills they have developed at school. For instance, they become engrossed in making origami whales which they then happily share with their friends.

Safeguarding

The arrangements for safeguarding are effective.

The manager and staff are confident in their understanding of their duty to keep children in their care safe. They confidently talk about the signs and symptoms which may cause them concern about the welfare of a child attending the club. The manager and staff know the procedures to follow if they have any concerns. They know how to identify a child who may be at risk of being exposed to extreme ideas or behaviours. Staff regularly complete relevant training. They understand their whistle-blowing duty and how to report any concerns they may have about the conduct of other professionals.
