Information about this children's home

This home may provide accommodation and therapeutic care for two children who are affected by mental ill-health. It is owned and operated by a small private company. The manager was registered with Ofsted to manage the home in October 2019.

This monitoring visit

This home was judged inadequate at a full inspection on 5 and 6 June 2019 when 10 regulatory breaches were found. At the time of a monitoring visit on 31 July 2018, the one child who was living at the home had moved out, and no children were living in the home. The home's management had made good progress, and nine requirements had been met. A requirement in relation to staffing levels and staff experience remained unmet.

Due to insufficient staffing levels, including there being no manager in post, the responsible individual decided that the home was not in a position for children to move in. The responsible individual agreed to notify Ofsted when the home was ready for children to move in, so that the regulator could assess its readiness for this.

In July 2019, the responsible individual notified Ofsted that a new manager had been recruited and the home was preparing for children to move in. After relevant checks were undertaken by Ofsted, this visit was arranged to assess the manager's fitness to manage the home and to assess whether the home was ready to accept children.

The new manager met the criteria to be registered with Ofsted. The home's management has updated all the home's records, policies and guidance in the period during which the home has not had children living there. New staff have been

employed and h training in preparation for children moving into the home. The home has been well maintained and is an attractive, homely and nurturing environment.

It is Ofsted's opinion that the home is ready for children to move in.
