## Summary of key findings

### This provision meets requirements

- The area manager and the owner discussed how they use self-evaluation to reflect on their practice and the practice of their staff to help them to improve and develop their provision continually. They are aware of the importance of including the views and opinions of staff, parents and children.
- The area manager, owner, club supervisor and staff understand their duty to keep children safe. They recognise all indicators that a child might be at risk of harm and know the procedure to follow. Most staff hold a relevant paediatric first-aid certificate and complete safeguarding training. Staff who do not hold a paediatric first-aid qualification are booked on training courses to be completed within the term.
- The area manager, owner and staff understand how to support children to develop healthy lifestyles. They provide healthy snacks and opportunities for children to have daily physical exercise.
- Children are provided with a safe and suitable environment in which to play and learn. Activities and resources reflect the ages and stages of the children attending and reflect their current interests.
- The supervisor of the setting and staff work closely with the host school and any other professionals who support the children's learning and development. The club supervisor and staff understand how to plan children's learning and activities to reflect what children are learning at school.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- A meeting was held between the inspector, the area manager and the owner to discuss arrangements for self-evaluation, safe recruitment and staff's suitability checks.
- The inspector had a tour of the premises and discussed the security measures and risk assessments.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
