Context of the inspection

A full inspection took place between 4 and 6 July 2019. At that inspection, this service was judged to be inadequate across all areas.

This inspection was carried out to review progress made and was aligned with an education inspection.

Summary of the progress made in implementing the action plan

Not enough action has been taken to address shortfalls identified at the previous inspection. Primarily, these are in respect of the welfare and safety of children. Inspectors identified six cases where safeguarding concerns have not had swift or appropriate responses. This has left children at potential risk of harm.

Policy and process regarding referrals to the designated officer are not fully understood by staff. There have been three referrals since the last inspection. None of these have followed due process.

New systems to manage safeguarding concerns are not wholly effective. This is compounded further because oversight by leaders and managers is weak.

The arrangements in place for the safekeeping and administration of medication are effective'. Improved systems and regular auditing support the process. Because of this action, errors are identified early and addressed.

Staff have received some good training since the last inspection. This coupled with improved supervision has had a positive impact on their practice. Staff told the inspector that they feel more confident and able to carry out their duties.

National minimum standards

The school must meet the following national minimum standards for residential special schools:

- 6.3 The school ensures that the welfare of pupils at the school is safeguarded and promoted by the drawing up and effective implementation of a written risk assessment policy and appropriate action is taken to reduce risks that are identified.
- 11.1 The school ensures that: arrangements are made to safeguard and promote the welfare of children at the school; and such arrangements have regard to any guidance issued by the Secretary of State.
- 13.3 The school's leadership and management demonstrate good skills and knowledge appropriate to their role.
- 13.4 The school's leadership and management consistently fulfil their responsibilities effectively so that the standards are met.
- 13.6 Staff with management responsibilities have an adequate level of experience or training in the management and practice of boarding to ensure that children's welfare is safeguarded and promoted.

Information about this school

WESC Foundation is situated in Exeter, Devon. The charity provides specialist services for children and adults with visual impairment and complex needs. The charity has a 14-acre campus from which all its services are run. WESC Foundation provides a range of services for adults including a residential care home, day services and supported living. WESC Foundation also runs a school for students aged 5-16 and a college for students aged 16-25. The school and college has residential provision.

The residential accommodation for students in school is predominantly located in two houses on the campus. The houses offer boarding from 1 to 4 nights weekly. Other residential students under 18 who access the post-16 college provision are accommodated in other buildings, creating a student village environment.

WESC Foundation has a range of specialist health, mobility and therapy services on site supporting students in school and college and adults living in the residential care setting. There is an onsite sensory room, hydrotherapy pool, swimming pool and specialist visual impairment facilities. The campus is adapted to meet the needs of young people using wheelchairs.
