Summary of key findings

This provision meets requirements

- The provider shows that he has a secure understanding of how to safeguard children. He has completed child protection training and knows what to do if concerns arise. He describes how he would address possible risks to children's health and safety, and shows a good understanding of how to work with others to help protect children's welfare.
- The provider is aware of the need to plan interesting and engaging experiences based on children's individual needs and interests. He demonstrates a good understanding of how to implement activities and routines that reflect the backgrounds of children attending the club.
- The provider shows a strong commitment to building warm relationships with children and their parents. He describes how he will help children to acquire positive social skills and understand what is expected of them.
- The provider recognises the importance of establishing effective partnerships with others who may be involved in children's care and development. He describes how he would share relevant information and work with other professionals when necessary.
- Staff show that they implement the club's policies effectively. They maintain accurate records of children's arrival and departure and seek written permission from parents before medication is administered. Accidents are dealt with appropriately and information is shared with parents.
- The provider explains his arrangements to seek the views of parents and children to evaluate and develop the service so children continue to achieve positive outcomes.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Aspire Childcare Project at Ilderton School registered in 2012. The out-of-school club operates from Ilderton Primary School in the London Borough of Southwark. It is open each weekday from 3.30pm to 6.45pm after school and from 8am to 6pm during the Easter and summer school holidays. Five staff work with children. Three staff, including the manager, hold relevant qualifications at level 3 and level 2.

- The inspector discussed the safeguarding and welfare requirements with the provider and checked evidence of the suitability of staff.
- The inspector reviewed documents, including attendance registers, staff disclosure and barring service records and children's activity plans.
