Summary of key findings

This provision meets requirements

- The childminder demonstrates a secure knowledge of the early years foundation stage requirements. She understands her role and responsibilities to safeguard the children she cares for. She knows how to protect children and what to do if she has a concern about a child in her care. The childminder keeps herself up to date with all aspects of safeguarding matters.
- Risk assessments, policies and procedures are embedded well and shared with parents. The childminder knows to adhere to and review these on a regular basis in order to promote children's health, well-being and safety effectively.
- Partnerships with parents and schools are well established. The childminder understands the importance of working in collaboration with others and sharing essential information to ensure continuity for children's care.
- The childminder evaluates her provision of care well. She has links with other childminder colleagues and early years professionals. She values the views of parents and children. The childminder regularly updates her knowledge and skills, for example, through training and research. For instance, training for safeguarding and paediatric first aid is up to date.
- Children are offered a broad range of toys, games, books, resources and activities before and after the school day. The childminder understands the importance of supporting children to be interested and motivated in order to build on what they already know. She places a high focus on helping children to have positive attitudes to their learning.
- The childminder is keen to promote British values and the ways children are respectful to each other. She helps them develop awareness of diversity and each other's differences. The childminder achieves this, for example, through celebrating a range of festivals, helping children to listen when others speak and taking part in activities that promote working together. The childminder plans outings in the local community to help children learn more about the wider world.
- The childminder is aware of the importance of supporting children's personal development. She knows how to promote healthy lifestyles, for example by offering children outdoor play and learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector spoke with the childminder about how effectively she works with her assistant.
