Summary of key findings

This provision does not meet requirements

- The childminder does not understand all safeguarding issues, including the referral process if she has a concern about a child's welfare. She has not kept up to date with current legislation, in particular the 'Prevent' duty guidance, to enable her to safeguard children from extreme views and behaviours.
- The childminder has an insufficient understanding of the learning and development requirements of the curriculum. She does not understand the importance of assessing children's progress to inform effective planning for their next steps.
- The childminder does not know about the requirement to complete a progress check for children aged between two and three years to identify their learning needs and to share these with parents.
- The childminder does not use self-evaluation effectively to identify the strengths of her provision and areas for improvement. She has not kept her knowledge about changes to legislation and the curriculum up to date, to enable her to plan appropriate learning experiences for children.
- The childminder understands the importance of managing children's behaviour, and of teaching them how to build good relationships with others and accept differences between people.
- The childminder knows how to complete risk assessments of her home to identify and minimise potential hazards to children's safety. The childminder's premises are safe and very clean.
- The childminder has a suitable understanding of how to promote healthy lifestyles. She explains how she would provide children with healthy meals and activities to help them exercise, such as trips to the local parks.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:



develop a secure knowledge and understanding of the government's 'Prevent' duty guidance and have a full awareness of who to contact in the event of any concerns about a child	17/02/2020
increase knowledge and understanding of the early years foundation stage curriculum and how to plan for children's learning and assess their progress	06/03/2020
develop an understanding of the requirement to check children's progress when they are aged between two and three years, and to provide parents with a written summary of their children's development.	06/03/2020

Inspection activities

- The inspector had a tour of the premises and checked all areas of the home that the childminder plans to use when caring for children.
- The inspector held discussions with the childminder about her knowledge of the early years foundation stage, including how she intends to assess children's abilities and plan for their progress.
- The inspector viewed and discussed a selection of the childminder's documents, including evidence of her suitability.
- The inspector discussed with the childminder how she plans to keep children safe and healthy, how she assesses any risks to children and her methods for evaluating her provision.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
