Overall outcome

The school does not meet all of the independent school standards that were checked during this inspection

Main inspection findings

Part 1. Quality of education provided

Paragraphs 2(1)-2(1)(b)(i), 3, 3(a), 3(c)-(e), 3(g) and 4

- The registration authority requested that the aspects of the quality of education provided by the school be reviewed as a result of complaints that had been received.
- The proprietor has not ensured that the curriculum policy and schemes of work are sufficiently ambitious for pupils. Nor do the plans give due consideration to pupils' prior learning or their particular needs. Across the school, the quality of education is highly variable. Too often, lessons are not planned well, and teaching staff do not check what pupils have learned. In some subjects, improvements can be seen but these are very recent.
- Work is often incomplete, and errors go unchecked, so some teachers are unclear about what pupils have learned. Consequently, pupils do not make good progress. The accuracy of pupils' written English in a range of subjects is weak. Currently, there is no assessment framework in place. However, staff have been reviewing this and arrangements are in place to introduce a new school-wide system this term.
- The standards in these paragraphs are not met.

Paragraphs 2(1)(b)(ii), 2(2)-2(2)(b), 2(2)(d)-2(2)(e)(iii), 2(2)(h), 3(b), 3(f) and 3(h)

- Pupils benefit from full-time education provision and receive lessons in a range of subjects, such as English, mathematics, biology and geography. The resources in place are of good quality.
- Teachers provide a personal, social, health and economic (PSHE) education programme that helps pupils understand about society and their place in it. The programme includes teaching about democracy, the rule of law and an understanding of different faiths and beliefs.
- Pupils benefit from a range of activities that helps them to understand different career pathways, including an on-site careers fair organised by the pupils and visits to further education colleges.
- These aspects of the standards are met.
- Overall, however, the standards in this part are not met.

Part 3. Welfare, health and safety of pupils

Paragraph 7–7(b)

- The arrangements to confirm that pupils are safe at the school are a feature of all inspections.
- Staff have had recent training in safeguarding, including the risks from radicalisation and extremism. Staff who have joined the school recently commented on the safeguarding training they received as part of their induction to working at the school.
- However, the school's safeguarding and child protection policy does not reflect the latest guidance issued by the Secretary of State. For example, there is no reference to upskirting or contextual safeguarding.
- Furthermore, the proprietor has not ensured that the safer recruitment arrangements set out in 'Keeping children safe in education', 2019 have been followed fully. Some of the checks required when appointing new staff are missing.
- The standard regarding safeguarding arrangements is not met.

Paragraph 16–16(b)

- At the previous progress monitoring inspection, the inspector found risk assessments to be of poor quality. Leaders have made concentrated efforts to make sure that these have improved. The proprietor has organised training for staff and one member of staff has oversight of the completed risk assessments.
- Risk assessments completed when taking pupils off site now give detailed consideration to the specific needs of pupils who are attending. However, the examples reviewed are still not completed well as they often omit or misidentify the hazards associated with the activity. The control mechanisms put in place by leaders are not suitably robust.
- Leaders were unable to provide risk assessments for routine on-site activities, such as science experiments or cookery.
- The risk assessment policy in place does not clearly show how the assessments are to be carried out.
- The standard in this paragraph remains unmet.

Part 4. Suitability of staff, supply staff, and proprietors

Paragraph 18(2), 18(2)(b), 18(2)(e), 18(3) and 21(1), 21(3), 21(3)(a), (iii), (viii) and 21(3)(b)

- A number of members of staff have joined the school since the July 2019 inspection. The proprietor has not ensured that all the checks required of prospective new staff have been carried out before they take up their roles. For example, prohibition checks for teachers have not been completed and checks for a member of staff who worked overseas have not been obtained.
- The standards in these paragraphs are not met.

Paragraphs 18(2)(a), 18(2)(c)–18(2)(d), 21(2) and 21(3)(a)(i), (ii), (iv)–(vii)

- The proprietor has ensured that the identity, medical fitness, right to work in the United Kingdom and their qualifications of all staff members have been checked. These details are recorded in the school's register.
- The standards in these paragraphs are met.

Part 8. Quality of leadership in and management of schools

Paragraph 34(1)-34(1)(c)

- The proprietor and leaders have not yet grasped fully the requirements of the independent school standards. Consequently, several are not met. The proprietor has recognised this and has continued to employ an external consultant to help the school with this aspect of their work. The new headteacher is quickly familiarising herself with the standards and is keen to ensure that the school complies fully and consistently. Plans are in place to bring these about but the checks to ensure that progress is being made are not rigorous enough. Nonetheless, the proprietor, headteacher and staff show a commitment and eagerness to meet the standards. The proprietor is ensuring that staff have sufficient resources to achieve this.
- The proprietor and leaders cannot assure themselves that pupils' well-being is actively promoted as there are missing checks for new staff and the quality of risk assessments does not yet meet the required standard.
- The standard in this part remains unmet.



Compliance with regulatory requirements

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

Information about this school

- Fusion College is an independent special school. The school was established in 2005 and, until recently, was known as Willows. It moved to its current site in 2007.
- The school offers provision for up to 16 girls who have severe social, emotional and behavioural difficulties.
- Pupils are placed by their respective local authority.
- The proprietor has responsibility for the governance of the school.

- The school does not use any alternative provision.
- The school's previous standard inspection took place on 16–18 January 2018, when it was judged to be inadequate and a number of independent school standards were not met. Following this, progress monitoring inspections took place in September 2018 and July 2019 when several independent school standards remained unmet.



Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This was the third progress monitoring inspection since the standard inspection in January 2018.
- At the registration authority's request, the proprietor produced an action plan. This was evaluated by Ofsted in October 2019. The registration authority rejected the school's action plan.
- The inspection was carried out without notice.
- During the inspection, the inspector held discussions with the proprietor, headteacher, designated safeguarding lead and a group of teaching staff. The inspector visited lessons and spoke with pupils. The headteacher accompanied the inspector on some lesson visits. A range of the school's documentation, including policies, risk assessments, schemes of learning, and other records maintained by school staff were scrutinised.

 - 34(1)(c) actively promote the well-being of pupils.

 - 2(1)(b)(i) take into account the ages, aptitudes and needs of all pupils, including those pupils with an EHC plan.
- 3 The standard in this paragraph is met if the proprietor ensures that the teaching at the school—
 - 3(a) enables pupils to acquire new knowledge and make good progress according to their ability so that they increase their understanding and develop their skills in the subjects taught;
 - 3(c) involves well planned lessons and effective teaching methods, activities and management of class time;

- 3(d) shows a good understanding of the aptitudes, needs and prior attainments of the pupils, and ensures that these are taken into account in the planning of lessons;
- 3(e) demonstrates good knowledge and understanding of the subject matter being taught;
- 3(g) demonstrates that a framework is in place to assess pupils' work regularly and thoroughly and use information from that assessment to plan teaching so that pupils can progress.
- 4 The standard in this paragraph is met where the proprietor ensures that a framework for pupil performance to be evaluated, by reference to the school's own aims as provided to parents or national norms, or to both, is in place.

Part 3. Welfare, health and safety of pupils

- 7 The standard in this paragraph is met if the proprietor ensures that—
 - 7(a) arrangements are made to safeguard and promote the welfare of pupils at the school; and

- 21(1) The standard in this paragraph is met if the proprietor keeps a register which shows such of the information referred to in sub-paragraphs (3) to (7) as is applicable to the school in question.
- 21(3) The information referred to in this sub-paragraph is—
 - 21(3)(a) in relation to each member of staff ("S") appointed on or after 1st May 2007, whether—
 - 21(3)(a)(iii) a check was made to establish whether S is subject to any direction made under section 128 of the 2008 Act or section 142 of the 2002 Act or any disqualification, prohibition or restriction which takes effect as if contained in such a direction;

- 21(3)(a)(viii) checks were made pursuant to paragraph 18(2)(e),
- 21(3)(b) in relation to each member of staff ("S"), whether a check was made to establish whether S is subject to a prohibition order or an interim prohibition order, including the date on which such check was completed.
