## **Summary of key findings**

### This provision does not meet requirements

- The childminder has failed to notify Ofsted of a significant event that can affect the suitability of household members. This is a breach of welfare requirements and puts the safety and well-being of children at risk.
- The childminder demonstrates an understanding of child protection procedures and what steps to follow if she has any safeguarding concerns regarding minded children.
- The childminder has the required public liability and first aid in place.
- The childminder demonstrates an understanding of behaviour management.
- The childminder is aware of working with parents and other agencies sharing children's progress.
- The childminder demonstrates an understanding of reviewing children's learning and development and keeping her training up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
