This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection.

At the interim inspection, Ofsted judges that it has improved effectiveness.

Since the appointment of a new manager, there have been improvements in a number of areas. The requirements and recommendations from the previous inspection have been met and a development plan is being implemented. This has improved the quality of care offered to the children, helping them to make progress.

The manager has reviewed working practices and developed an educational, supportive environment. This has led to the children receiving consistently good care from staff who are confident and skilled in understanding their needs. Staff are effective in helping the children to manage their emotions, and this has seen a significant reduction in incidents. This has improved children's well-being and dignity.

The manager and her staff have ensured that the children are listened to and involved in their individual care-planning and the development of the home. This ensures that the children are supported to develop a sense of pride and responsibility in the home.

The key-working role in the home has been revamped, and the sessions with the children are purposeful. Staff understand their roles and have developed a positive relationship with the children that is based on trust and respect. The children commented positively on the professionalism of the staff.

The children are helped to attend education and their health needs are met. The children are supported to have family time, which staff promote through good communication and a flexible approach. This involves providing transport and facilitating family time, both in the home and in the community. This supports children to develop a sense of identity.

Sanctions are used to help the children to understand and be accountable for their actions. However, these have not been consistently applied or evaluated. This limits their effectiveness in changing behaviour.

Care-planning documentation has been reviewed by the manager and effective monitoring systems are now embedded. However, the manager has not ensured that the internal monitoring report required by regulation has been sent to Ofsted in a timely manner.

The manager has strengthened the supervision of staff. She has introduced a progression pathway. This not only promotes staff development but supports the



children by ensuring that they live in a positive and supportive environment in which achievement is both recognised and celebrated.

What does the children's home need to do to improve?

Recommendations

In particular, any sanctions implemented should be consistently recorded in the home's reporting system and a relevant evaluation carried out.
