The quality and standards of early years provision

What is it like to attend this early years setting?

This provision does not meet requirements

Children form strong attachments with staff and make close friendships with their peers. They help to make the rules for the club and these are displayed on the wall. This helps to promote children's positive behaviour. Children share resources, manage turn taking, and show consideration and respect towards each other. Staff praise them for being polite and well mannered. The safe and familiar environment enables children to settle quickly. A sufficient range of resources is appropriately organised inside. However, the outdoor area is rarely used and there is very little to attract them into the area. This limits children's physical development.

The environment is secure and welcoming. Staff are loving and attentive. They get to know children and their families well from the start. Children are happy and relaxed here. They show good levels of confidence and self-esteem. Children enjoy pretending to be a shopkeeper and serving their customers. They talk about how much money the food costs. Children are provided with healthy food and they enjoy their social snack time. Their independence skills are promoted. Children pour their own drinks and put their own coat and shoes on when it is time to go home. However, the arrangements for managers' and staff's performance management are not good enough. Staff do not have opportunities to develop their skills further and improve the quality of care that they provide.

What does the early years setting do well and what does it need to do better?

- The management team is unable to accurately identify the gaps and weaknesses of the provision. Therefore, they do not know how to improve the quality of the care and learning that they provide. The arrangements for the performance management of staff are weak. Managers and staff do not benefit from a programme of ongoing supervision and training. Staff are not supported well in their roles and their training needs are not identified. This does not help to foster teamwork and mutual support, or promote continuous improvement across the provision. Staff lack an up-to-date understanding of their responsibilities for safeguarding, including the 'Prevent' duty. The manager does not have effective systems in place to ensure that people working with children are suitable.
- Children are confident to express their own ideas. They make choices about what they want to play with to lead their own learning. Younger children enjoy making new friendships. They giggle as they play tag with each other inside. However, staff do not promote the use of the outdoor area on a daily basis. The outdoor area is only used when the weather is 'nice'. This is limiting the children's physical development. Staff do not provide children with enough opportunities to develop their physical skills, such as balancing, climbing,



- catching and throwing.
- Staff greet children warmly. They are interested in children's news and their day. As a result, children are keen to interact with their key person and other staff. Children are excited to spend time with both staff and their friends. They know the routine of the club well. For example, they hang up their coats independently and store their things away neatly before setting off to play. Staff know when the children are tired, hungry or unwell. They respond appropriately to ensure their individual needs are met.
- Staff listen to the views of children and parents. This provides them with ideas about how they can improve their service. Staff have taken on board parental feedback. They help children to complete their homework while at the club. During the inspection, children enjoyed completing their reading homework with staff. Staff listen to and act upon children's views. They have recently bought a large, four-in-a-row game as requested by the older children. The manager and staff have built good partnerships with parents. Parents are pleased with the service that the club provides. They are happy with the good levels of communication between themselves and the club. This helps to promote continuity for children's care and learning.

Safeguarding

The arrangements for safeguarding are not effective.

The manager and staff are aware of potential indicators of abuse and know the procedures to follow should they have a child protection concern. Staff complete daily risk assessment checks on all aspects of the club. This helps to ensure that the environment, toys and equipment are continually suitable. However, leaders do not ensure that staff have an up-to-date knowledge of their roles and responsibilities regarding other aspects of safeguarding, including the 'Prevent' duty. They do not ensure that people looking after children are suitable to fulfil the requirements of their roles. Leaders do not record information about the identity checks that have been completed.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:
