Summary of key findings

This provision meets requirements

- The managers know how to meet the emotional needs of children of all ages. They understand the importance of providing a safe, secure and friendly environment for children to play and explore in.
- The managers have effective systems in place to support staff professional development. Staff are given many opportunities to develop their learning further. Staff practice is carefully monitored to make sure they are providing children with the best possible care.
- The managers know how to organise the deployment of staff to ensure a good level of supervision and one-to-one support for individual children as required.
- The managers and staff understand their role in safeguarding and protecting children within their care. They are aware of signs and symptoms that may cause them concerns about the welfare of children and know the reporting procedures. Staff have regular and detailed safeguarding training to keep their knowledge and understanding up to date at all times.
- The managers have a clear understanding of how children learn and how to plan activities and experiences that meet children's individual needs and interests.
- The managers understand the importance of strong partnerships with parents. Parents have the opportunity to share their opinions and ideas on a regular basis.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Fit For Sport At Oxford Gardens is one of several run by Fit For Sport Limited. It registered in 2017 and operates within Oxford Gardens Primary School in Kensington and Chelsea. The setting opens five days a week during term time from 3pm to 6pm and offers holidays camps during school holidays. The setting employs a team of four staff. Of these, one holds an appropriate qualification at level 6, one holds a qualification at level 5 and two have level 3 qualifications.
