What is it like to attend this early years setting?

The provision is outstanding

The childminder and her assistant provide an exceedingly warm and welcoming environment where children demonstrate that they feel incredibly confident and secure. They are highly responsive to children's needs and offer children reassurance and cuddles. Children are very happy and self-assured. The childminder and her assistant have extremely high expectations for children's behaviour, and this is reflected in the way that children behave. They are kind and very polite.

The childminder offers an excellent curriculum and provides children with an inspiring range of activities. She engages in children's play and is skilled at interacting with them. This is demonstrated as children enthusiastically use her as a patient in their hospital and as a police officer in their traffic-light game. Children are keen learners and focus on activities for long periods of time, demonstrating excellent levels of engagement.

The childminder helps children make exceptional progress in their speech. She constantly introduces new words. For example, children learn an edible snail is called 'escargot'. Children select books and react with delight as they successfully retell their favourite parts of familiar stories. They tell simple jokes and laugh at their punchlines. They gain an excellent sense of responsibility. For instance, at lunchtime they chat about allergies and know how some children cannot eat particular foods as they may become ill.

What does the early years setting do well and what does it need to do better?

- The childminder has an excellent understanding of how children learn. She uses her ongoing observations to understand children's starting points, interests and learning styles. She incorporates their next steps in learning into her planning. This has a very positive impact on developing children's knowledge and skills across all areas of learning.
- The childminder has developed exemplary partnerships with parents, who praise her and her assistant highly for the 'phenomenal' care and attention given to their children. This successful relationship plays an extremely strong part in helping the childminder to meet children's individual needs.
- Children behave remarkably well and develop firm friendships with each other. The childminder and her assistant praise children, building on their self-esteem exceptionally well. Children are extremely thoughtful and caring. This is evident when older children praise younger children for sharing the resources.
- The childminder has a clear vision for her setting. Through very effective selfevaluation, she has maintained the outstanding standards of practice. For instance, since the last inspection she has extended the already excellent range



- of play equipment so that older children who learn best outside continue to make rapid progress.
- There is an array of different resources which help to encourage children's imaginations. This is evident when children play in a pretend hospital and use a 'stethoscope' to hear their heartbeats. They learn that a 'thermometer' measures temperature and that an 'x-ray' is a photograph of the bones in the body. The childminder extends the children's vocabulary extremely well.
- The childminder works very well with her assistant and identifies any training or support needs quickly. She builds on her professional development according to the needs of children. For instance, after attending a training course she has a better understanding of how boys learn. This helps all children to achieve at the highest level.
- Children enjoy nutritious and healthy home-cooked meals, such as fish pie with spinach. They enjoy a variety of healthy snacks such as blueberries, satsumas, apples and wheat snacks. The childminder promotes children's understanding of healthy living very well.
- The children develop excellent levels of independence and learn how to tend to their self-care needs from an early age. They clean their hands before food or after toileting and discuss the need to wash away the germs.
- The children have wonderful opportunities to explore the wider world. They go on outings to the park, the woods, soft-play areas, the beach and meetings with other childminders. The childminder uses these opportunities to develop the children's excellent social and physical skills. Children are extremely articulate and confident when talking to visitors.
- Children learn about disabilities well. For instance, they play with toys in wheelchairs and know some people cannot walk. They learn to respect each other and are exceptionally considerate.

Safeguarding

The arrangements for safeguarding are effective.

The childminder and her assistant have a very good understanding of their responsibilities to keep children safe. They have a secure knowledge of the signs and symptoms that a child may be at risk of abuse. Additionally, they know the procedures to follow and professionals to contact if they have any concerns about wider safeguarding issues. The childminder reviews her policies and procedures regularly to ensure they are kept up to date with any changes. She ensures that both she and her assistant have attended current paediatric first-aid training and that their safeguarding knowledge is routinely refreshed. The childminder checks the premises to minimise potential risks and teaches children what to do in the event of an emergency.
