## **Overall outcome**

# The school does not meet all of the independent school standards that were checked during this inspection

## Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraphs 7, 7(a) and 7(b)

- At the previous material change inspection in August 2019, leaders' enhanced safeguarding training had lapsed. Information to evidence leaders' actions in managing concerns, referrals and actions taken was unavailable. Leaders spoken to did not have a clear enough understanding of how to keep pupils safe from harm.
- This inspection found staff to have been suitably trained earlier this month in line with the latest statutory guidance. Leaders also completed some suitable online training in October 2019, two months after the previous inspection. However, the school's child protection policy no longer reflects the latest guidance issued by the Secretary of State. Though the first two pages of the policy state that the September 2019 'Keeping children safe in education' guidance is followed, this is contradicted on the third page onwards, and the key changes in guidance are not reflected or referenced in the policy. The policy also wrongly states that the designated safeguarding leader is somebody who left the school in August 2019. Leaders spoken to again did not have a sharp understanding of how to keep pupils as safe from harm as possible, especially in terms of the latest statutory guidance.
- The independent school standard remains not met.

## Paragraph 12

- At the previous inspection, there was not enough available evidence to confirm that the school complied with the Regulatory Reform (Fire Safety) Order 2005.
- This inspection confirms that the school does not comply with this legislation. The required checks on the emergency lighting are not taking place, and none are recorded. The required certification for fire safety checks is not in place. Leaders continue to rely entirely on the sparse evidence provided by the building's owners. The proprietors have not taken responsibility for fire safety on their floor of the shared premises.
- The independent school standard remains not met.



## Paragraph 16, 16(a) and 16(b)

- At the previous inspection, there was no written risk assessment policy, the written risk assessment for the premises was inadequate and there were no suitable written risk assessments for use of the nearby park and leisure centre facilities.
- This inspection found that there is now a risk assessment policy, but it seems to be copied from elsewhere. Its introduction sums up its lack of relevance and suitability: 'this policy is to state how our establishment deals with the requirements of the law regarding the safety of electrical systems and equipment'.
- Despite this, the risk assessment of the premises is now far more useful and credible. It is supplemented by suitable assessments for the use of nearby boxing and football facilities.
- The independent school standard remains not met.

## Paragraph 15

- In light of the reduction in the number of pupils on roll, the inspector scrutinised the admission register. The register does not include pupils' sex or full details of their previous schools. It is therefore not compliant with legislation.
- This independent school standard is now not met.
- The independent school standards checked in this part are not met.

## Part 4. Suitability of staff, supply staff, and proprietors

## Paragraphs 18(2), 18(2)(b), 21(1), 21(3), 21(3)(a), 21(3)(a)(ii) and 21(3)(a)(iii)

- The school's single central register (SCR) of vetting checks is now compliant, as it includes all the required information. This includes barred list checks, prohibition checks for all staff working with pupils, and enhanced Disclosure and Barring Service (DBS) checks. The inspector identified one omission on the SCR, which was rectified during the inspection.
- The independent school standards checked in this part are now met.

## Part 5. Premises of and accommodation at schools

## Paragraph 24(1), 24(1)(a), 24(1)(b) and 24(2)

- At the previous inspection, there was no medical room facility.
- This inspection found a portable washing facility and a camp bed to have been placed in a computing room with no signage. The washing facility was not equipped with water or soap and there were no medical supplies in the room. The camp bed was placed next to a pile of disused computer units and a broken chair.
- As there is still no suitable medical room facility, the independent school standards remain not met.
- The independent school standards checked in this part are not met.



## Part 6. Provision of information

Paragraph 32(1), 32(1)(c)

- In the absence of a website, the school's child protection policy is readily available to parents electronically or in hard copy.
- The independent school standard checked in this part continues to be met.
- The independent school standards checked in this part are met.

Part 8. Quality of leadership in and management of schools *Paragraph 34, 34(1)(a), 34(1)(b) and 34(1)(c)* 

- This inspection found there to have been very little progress in tackling the deficiencies identified in August 2019. There is a serious lack of attention to detail. This compromises quality, compliance and potentially pupils' safety. The proprietors are currently seeking support and guidance from new governors who may be able to help.
- Leaders acknowledge that the current premises are unsuitable and are vacating, and relocating, probably as soon as Easter 2020.
- The independent school standard checked in this part is again not met.



## **Compliance with regulatory requirements**

The school does not meet the requirements of the schedule to The Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

## Information about this school

- New Level Academy is a small independent school and alternative provider for pupils in the London Borough of Brent.
- The school provides permanent school placements and temporary alternative provision for up to 16 boys and girls with social, emotional and mental health needs. The school works with pupils excluded from, or at risk of exclusion from, schools in the vicinity. Most pupils are dual-registered. A very few pupils have education, health and care plans. The number of pupils on roll has decreased since the previous inspection.



- The school makes no use of alternative provision. However, pupils attend physical education sessions at the boxing gym which is located within the same building as the school (Stonebridge boxing club) and football sessions at Powerleague, Wembley HA9 0EG.
- Leaders have decided not to pursue any application to extend their age range or increase numbers.
- The school intends to vacate its current premises in the near future. It is most likely that the school will relocate to new premises at 45 Denmark Road, Kilburn NW6 5BP.



## Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This first progress monitoring inspection, commissioned by the registration authority since the school's material change inspection in August 2019, was conducted without notice. Since the August 2019 inspection, the school was asked to submit an action plan. It was judged by Ofsted as unacceptable, and subsequently rejected by the Department for Education (DfE).
- The DfE requested that the inspector consider whether particular independent school standards contained within Parts 3, 4, 5, 6 and 8 are now met.
- The inspector met with the chair of the proprietorial body, who is also the headteacher. He toured the school's premises, checked the single central register of vetting checks, and considered a range of documentation in relation to safeguarding, health and safety and risk assessment.
- The chair of the proprietorial body was clear that the school no longer wishes to make any material changes to its registration agreement with the DfE. This inspection therefore only considered the school's progress in meeting the independent school standards judged as unmet in August 2019.
- There were not enough recent responses to Ofsted's online survey (Parent View) to consider as part of this inspection.
