What is it like to attend this early years setting?

The provision requires improvement

The owner has not ensured that the setting employs a deputy manager. Nor have they ensured all aspects of staff recruitment are as rigorous as they should be. Both are requirements of registration. That said, this cosy nursery offers a welcoming and safe environment filled with natural resources.

The focus on literacy and developing children's speech and vocabulary is evident. An enticing reading area, which is well used throughout each session, is the centre point of the nursery. The manager and staff read to, and sing with, the children throughout the day. This encourages children's speaking skills and extends their vocabulary. However, on occasion, staff do not pronounce words correctly.

There are a few instances where all required information about children is not obtained before they start. Nevertheless, staff know the children well, and they tailor teaching to children's individual needs. The small staff team works well together and provides children with exciting learning opportunities that are well considered.

Children are challenged in their physical development. They skilfully walk along balance beams and learn how to dismount safely. They are keen to demonstrate quite difficult yoga poses that they have learned at the nursery. Children make firm friends and include their peers in their play. They concentrate for extended periods on activities they choose and explain solutions to problems they face.

What does the early years setting do well and what does it need to do better?

- There is a significant focus by all staff on ensuring that children are exposed to a wide range of vocabulary. For example, traditional nursery rhymes are sung throughout the day. During nappy changes, younger children receive lots of verbal attention from staff, which helps them learn about two-way conversations and comforts them.
- Children are read to regularly. They are encouraged to join in and predict the next words in familiar books, helping to develop their love of reading. This can be seen in how carefully they handle books independently, and their requests for even more story time. However, not all staff consistently model speech well, to allow children to hear words correctly pronounced, as they develop their early speech.
- Parents are complimentary about the nursery and explain that they receive detailed information on how their children are progressing. They also explain how the staff give them ideas to support their children's learning further at home. For example, staff suggest that parents read to their children every night.
- Staff usually gather lots of precise information about children before they start



at the nursery. They establish children's likes and dislikes, information about health, allergies and what children can do. However, there are isolated instances where this is not done with rigour, and relevant information about children's complex health needs is not obtained. This risk is minimised by staff using their professional experience and knowledge to support children.

- The owner has a sound understanding of his safeguarding responsibilities in leading the nursery. In the main, recruitment and vetting of staff are robust and thorough. Unfortunately, there are isolated instances where not enough scrutiny has been given to specific aspects of the recruitment of some staff, such as obtaining references.
- At the time of this inspection the nursery did not have a named deputy manager in place. This means that contingency arrangements are not in place should the manager be absent. However, the owner is in the process of appointing a deputy.
- The manager ensures that children are equipped with the skills they need for the next stage in their learning. Children self-register on arrival each day, learn how to put on their own coats, and brush their teeth independently. Children understand the importance of self-care. They know to wash their hands after using the toilet or blowing their nose, with little prompting from staff. Children sit engrossed during story time and show their determination to succeed when building towers from blocks. Children's attitudes to learning are positive and they revel in demonstrating what they know and can do. Children treat each other kindly and mirror the positive behaviours of the staff team.
- Children learn about their local community through visits to the local church and mosque. They visit local shops where they learn about money and have the chance to buy ingredients for activities in the nursery.

Safeguarding

The arrangements for safeguarding are effective.

This is a safe and secure nursery at which staff ensure that unauthorised access is not possible. The owner and staff have a good knowledge of the indicators of possible abuse. They know how and where to report any concerns about a child's welfare. Staff have a good understanding of wider safeguarding matters, such as female genital mutilation and radicalisation. Staff understand their personal responsibility to report any safeguarding concerns. They know they need to report matters if they feel leaders are failing to take action. The manager reviews the premises, including the outdoor area, on a daily basis to ensure it is free from unnecessary risks.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage, the provider must:

Kids Corner Oldham Ltd registered in 2019. The provision is open each weekday from 9am to 3.10pm, term time only. The nursery employs five members of childcare staff, four of whom hold appropriate early years qualifications at level 3 or above. The nursery receives funding to provide free early education for two-, three- and four-year-old children.

Inspection activities

- This inspection was carried out following a risk assessment process.
- Discussions were held with the owner, manager and staff to establish their safeguarding knowledge.
- Parents' views on the nursery were sought, including their opinions on the strengths and areas for improvement.
- The inspector undertook a tour of the nursery, during which he discussed the nursery's approach to supporting children's learning.
- Observations were made of a range of learning activities, and the interactions between staff and children.
- The inspector reviewed a range of documentation relating to staff suitability and recruitment.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
