This is a privately owned home for three children and young people who have emotional and/or behavioural needs, and/or a mental disorder, and/or a learning disability. The provider has three other children's homes registered with Ofsted.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At this interim inspection, Ofsted judges that it has improved effectiveness.

Children and young people are positive about their experiences at the home and feel they are making progress. They enjoy working with staff and have good relationships with them. Children and young people feel safe, lead healthy lives and are encouraged to take their education seriously. They have fun and are working towards developing practical life skills.

The home's last inspection highlighted a number of shortfalls. All of these have been resolved. The home has undergone a programme of maintenance. There is new flooring in the kitchen and the bedrooms have been repainted. One bedroom, however, did not have net curtains or blinds on the window. This compromised the privacy of the young person occupying this room. Managers are considering using frosting on the windows, as the young person has previously removed the net curtains.

Managers have devised a development plan and are in the process of finalising the document to then share with staff. At the previous inspection, some staff lacked a good understanding of the action to take in the event of an allegation being made against a member of staff. Managers have since held regular discussions in team meetings and in individual supervision meetings with a focus on responding to allegations. Staff are now familiar with the home's procedures for managing allegations.

The home does not always notify Ofsted when serious incidents occur in the home. This relates to an incident when the police were called to the home and a young person was arrested. In this incident, records indicated that staff intervened physically to prevent the young person's destruction of property. Staff's actions were measured and appropriate. However, incident records do not describe staff's intervention as a form of restraint. Managers are to review physical intervention protocols and offer staff clear guidance about the recording of such incidents.

Managers' vetting practices of new staff are now thorough. Staff personnel files evidence full vetting and recruitment information. The recruitment of staff has been successful. Staff appraisals are now up to date and conducted at appropriate intervals.

The children's guide and complaints procedures have been revised. These documents are now informative and child-friendly. The information is now easy to read with useful, accurate details.

Recommendations

Records of restraint must be kept and should enable the registered person and staff to review the use of control, discipline and restraint to identify effective practice and respond where any issues or trends of concern emerge. The review should provide the opportunity for amending practice to ensure it meets the needs of each child. ('Guide to the children's homes regulations including the quality standards', page 49, paragraph 9.59)
