# The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

Since the last inspection one young person has moved into independent living. Staff listened to the young person's wishes and feelings and helped him to move on at a pace that was right for him. The other three young people have remained living in the home and continue to make good progress. For example, one young person is now working towards developing his independence skills. All young people continue to attend school and college.

The registered manager has continued to develop the service. As a result, all the requirements have been met from the previous inspection and no new requirements have been made.

The home environment has improved. For example, the bathroom refurbishment has been completed, new flooring has been fitted and the home has benefited from a new driveway and fencing. There are further areas of development planned to help maintain a homely environment.

The registered manager now ensures that all the necessary recruitment checks are carried out in line with regulation.

Young people are encouraged by staff to live healthy lifestyles and are taking part in the initiative 'race at your own pace'. This is encouraging the young people to take part in regular exercise. As a result, young people are leading healthier lifestyles than they were previously.

Young people continue to be settled in their home. There have been a low number of incidents and no incidents when young people have needed to be restrained to keep them safe from harm. When challenging incidents do occur, there is good joined-up working with family members and other professionals. All incidents have been followed up with key-worker sessions that have helped the young people to learn from and reflect on their behaviours.
