## What is it like to attend this early years setting?

#### The provision requires improvement

Overall, children are happy and settled in the nursery. They separate well from their parents and/or carers, as they are greeted by caring staff. Babies are well cared for in a warm, nurturing environment where individual routines are followed. Babies receive good attention from their key person when they are fed or have their nappy changed.

The quality of teaching across the nursery is inconsistent. Children aged two years and over are not provided with a good enough range of activities to capture and sustain their interest. Although staff position themselves around the room, they fail to engage effectively by extending and challenging children's learning. As a result, some children spend time wandering and are not engaged in purposeful play.

Older children's interest is captured well. They enjoy taking part in adult-led activities. For example, they have fun exploring and experimenting as they make 'magic spells' using water, bicarbonate of soda and food colouring. Staff sound out new words, such as 'vinegar', phonetically to support learning. Children successfully pronounce the magic words 'abracadabra, to make it go faster'.

# What does the early years setting do well and what does it need to do better?

- Managers use a range of systems, including supervision, peer observation, training opportunities and reflective practice, to monitor staff performance and children's progress. However, these are not being used to address weaknesses effectively in planning and delivery of the curriculum or to ensure the quality of teaching is at a consistently good level.
- The premises are safe and secure. However, staff give insufficient attention to planning and creating a stimulating learning environment for children. For example, activities do not consistently challenge children's learning. Some books are torn and not used in a way that encourages children to develop a love of books. Many of the crayons are blunt, thus preventing children from practising early writing skills. Some puzzles are incomplete, which hinders children ability to persevere and complete tasks. In addition, some of the toys and equipment used by children are worn and in need of replenishment.
- Children who are mobile have good opportunities to be physical outside, in all weathers. They splash in puddles, pedal tricycles and role play imaginatively in the mud kitchen. However, babies and those who are less mobile spend much of there time being carried around by staff. This does not offer them the opportunity to practise and develop their physical skills outdoors.
- Overall, staff support children's language skills. Most provide commentary as they play alongside the children and several ask open questions that encourage children to develop their thinking. However, some children, particularly those



who use dummies, are not consistently provided with good opportunities to practise speaking. In addition, staff do not offer opportunities for children who speak English as an additional language to use their home language in play and learning.

- Key persons get to know each child and their family, providing consistency and reassurance. Parents comment favourably on the nursery. They feel well informed about their child's care and learning, through regular feedback, which is both verbal and written. Children with special educational needs and/or disabilities are provided with appropriate support and information. Overall, staff work effectively with other agencies in order to help narrow any gaps in children's learning.
- Children learn to take turns and listen to instructions. Overall, children behave well. Staff are calm, and provide clear boundaries. Older children are learning to be independent as they clear away and wash their own crockery at snack time. They put on their outdoor clothes and boots and some show care and consideration for their friends, as they help those who find this task harder.

## **Safeguarding**

The arrangements for safeguarding are effective.

Managers and staff have a secure knowledge and understanding of safeguarding. They can identify signs and symptoms of possible abuse and understand reporting procedures, should they have concern about a child's welfare. Staff attend regular safeguarding training to keep their knowledge up to date. They are aware of wider safeguarding issues, including those relating to cultural practices and extreme views and beliefs. Robust recruitment procedures ensure that all those working with children are suitable. Staff carry out daily risk assessments to ensure the premises are secure and the equipment is safe.

#### **Inspection activities**

- The inspector spoke to a sample of parents and took account of their views.

The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
