What is it like to attend this early years setting?

The provision is outstanding

Children and extremely happy and they flourish as they attend this exceptionally nurturing and well-organised environment. The childminder is an excellent role model. She is extremely respectful towards children and provides consistent guidance to promote positive behaviour and understanding of boundaries. Children's behaviour is exemplary. The childminder forms superb attachments with all children and gives them constant praise for their achievements. They are continually busy and show their contentment as they explore within the play environment.

Children's experiences and needs are central to everything the childminder plans and organises. She plans an exceptionally broad curriculum, following children's interests very successfully to provide stimulating and creative experiences. For instance, they are highly motivated to create a 'zoo' environment for their favourite toy animals as they look forward to their outing to the zoo. Children explore the outdoors to find the natural materials needed for each animal. The childminder deeply engages them in exploration as she skilfully teaches them about each animal's natural habitat. Younger children are challenged to give meaning to the marks they create in the sand, while older children are encouraged to consider the difference in size and weight of the animals. The childminder has incredibly high expectations for the children's development and successfully extends their learning. They delight as they succeed in identifying where on the map of the world each animal originates from. Children gain an excellent understanding of the world.

What does the early years setting do well and what does it need to do better?

- The childminder is passionate about improving the service she provides. She regularly evaluates what she does and makes changes to drive forward improvement. The childminder ensures she is maintaining the highest standards for all children. She keeps her knowledge and skills up to date through attending regular training and sharing excellent practice and ideas with other childminders. Consequently, children have valuable learning experiences and are well equipped for future learning.
- The childminder has successfully developed the indoor and outdoor learning environment further to increase learning opportunities for all children. For example, children immerse themselves in the opportunities to dig and explore with natural materials. They benefit from an excellent range of freely accessible toys, resources and play experiences. The childminder uses these to continually build on children's interests and to encourage them to develop their communication and language skills.
- The childminder regularly evaluates what she does and makes changes to drive forward improvement. She ensures that children learn new vocabulary as she



talks to them and gives clear explanations to enhance their learning constantly throughout the day. They recognise their own names on display boards and the childminder helps the children find out information they would like to know from a range of literature, such as posters and books.

- There is a wide range of exciting and interesting books available to the children. The childminder uses books with them to learn about different things, relax and enjoy stories. They are extremely confident to talk about and share books together in different contexts. For example, children explore an exciting interactive book about London. They can pull tabs to make the pictures move in order to tell the story and discuss the iconic London attractions. The childminder reads with great enthusiasm and children demonstrate a genuine love of books and reading.
- Partnerships with parents are exceptional. The childminder involves every individual parent effectively with all aspects of their children's care, learning and development. She keeps parents updated about their children's learning through observations, photographs and regular assessments. Parents comment that the childminder is 'organised' and 'skilful'. They speak very highly about the childminder and say that 'her care is exemplary' and that children 'benefit from various social groups and exciting outings'. The childminder also supports parents and children in their home environment to ensure learning and development are consistent and children achieve the best possible outcomes.
- The childminder has developed highly effective working relationships with staff at the schools or other early years settings that children attend. She successfully shares relevant information to enable children's smooth transitions and thoroughly support their continuous learning.

Safeguarding

The arrangements for safeguarding are effective.

The childminder has an excellent knowledge of child protection issues, including wider safeguarding concerns. She actively promotes all aspects of safeguarding and knows who to contact if she has concerns about children's safety and welfare. The childminder makes children's safety the highest priority. She has a clear understanding of the procedures to follow in order to keep children safe. The environment is safe and secure. The childminder conducts thorough risk assessments of her home and any outings that children take part in.
