What is it like to attend this early years setting?

This provision does not meet requirements

Children of all ages settle quickly and begin playing together as they arrive at the club. They are happy and keen to socialise with their friends. They form good relationships with each other and staff. Although children are safe and secure overall, some staff do not have a robust enough knowledge of safeguarding procedures to ensure the highest standards are met. Children choose from a selection of stimulating and age-appropriate activities which are set out for them by staff. For example, some of the younger children play with plastic construction toys while others play with board games or art and craft activities. Children's social skills and confidence are strongly promoted. They have the opportunity to develop new friendships with children from other schools. They enjoy taking an active part in helping set the table for mealtimes and also helping to tidy up. Children consistently demonstrate positive attitudes and behaviours towards each other. They are aware of the boundaries of the setting and, when needed, remind their friends of the rules. Children show respect for the adults and each other. Older children enjoy taking care of the younger children. Adults have high expectations for children's behaviour. They encourage and support children to show kindness and help one another.

What does the early years setting do well and what does it need to do better?

- Staff teach children how to keep themselves safe. For instance, they practise regular fire evacuation procedures to raise children's awareness of what to do in the event of an emergency. However, not all staff have a secure knowledge of safeguarding issues and an understanding of the correct procedures to follow to keep children safe from potential or actual harm.
- All children remain involved in play throughout their time at the club. They make independent choices as they play, selecting what games and resources they would like to get out and where they want to play. For example, some children decide to rearrange how the activities are set up and move the puzzle to another section of the room.
- Adults model positive behaviour and suggest ways that children can work together. Staff are friendly and attentive. This helps children to form close bonds with staff, which supports their emotional well-being.
- Staff engage with children well, joining activities and playing games with them. Children are respectful and support each other while waiting for their turn during group games. They play well together and offer support to one another. For example, during table tennis, children cheer on others and celebrate as they score or win.
- Adults involve children in some of the daily tasks, such as setting the table at mealtimes and clearing away the resources and toys. Children willingly and



happily carry out these tasks. For example, putting out the water cups and serving some of the food. This helps them learn about responsibility. Older children keep watch of the younger ones, and stay close by and offer help if they think they need it.

- Children show a good understanding of hygiene practice and remember to wash their hands before eating.
- There are positive partnerships between the staff, parents and schools. Staff work closely with the schools and parents to identify meaningful ways to support children and families. For instance, the club plans in time for children to complete homework, do exam preparation, and get support with any school work they may have, such as play rehearsals.
- Parents state that they feel well supported and share that they are very pleased with the club and that children enjoy attending. They feel it is a reliable and flexible service which meets their needs.
- Parents and children share that they enjoy meeting friends from different schools at the club. This further supports children's social skills.
- Leaders and managers consider the needs of the range of children that attend and alter the provision accordingly.
- Leaders and managers have a clear vision to support children in growing in their confidence, self-esteem and care towards each other. Staff know children well and use this to respond sensitively to their needs.

Safeguarding

The arrangements for safeguarding are not effective.

Staff teach and support children to be safe as they travel to the club and while they play with their friends. However, not all staff demonstrate a sufficient or secure knowledge of how to keep children safe in the event of a concern about a child or an allegation against an adult. Although the club has a safeguarding policy and procedure, staff lack awareness and knowledge of this written safeguarding procedure and the necessary steps to follow. Staff are not clear how to escalate safeguarding concerns and the reporting requirements. This shows that staff do not currently have the ability to follow correct procedures to swiftly and effectively prevent and protect children from harm or those who may be at risk of abuse.

What does the setting need to do to improve?

To meet the requirements of the Childcare Register, the provider must:

- All staff were spoken with at appropriate times during the inspection.
- The inspector held regular meetings throughout the inspection, to keep the manager updated.
