# The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

Since the last inspection, two children have arrived at the home. Leaders and managers have critically assessed the matching and impact of the new children on those already living at the home. As a result, the children are well matched and have positive relationships with each other.

The children are making good progress, and all are engaged positively with education. This is a real achievement as children have overcome significant barriers to learning. Education provision is creatively managed and bespoke for some children, while others attend local schools.

The children's voice is heard. When complaints have been made, there are clear records which demonstrate that the adults take a believing approach. Where appropriate, information is shared with relevant agencies, such as the designated officer, to further safeguard the children.

Overall incidents are well managed. The manager and director oversee all measures of restrictive practice. Their scrutiny of the records has enabled them to identify patterns and trends and, in some cases, provide the adults with development plans to further guide their practice.

Development plans include the introduction of a streamlined recording and reporting system. The manager and some senior staff are already trained in preparation for the launch planned for March 2020.

Good progress has been made in meeting the previous requirements. Regular team development days are being held to reflect on practice and develop staff skills through coaching and mentoring. The culture of the home has become increasingly child focused. Effective working with the wider network is providing the children with consistency in the team that works around them.
