Monitoring visit
Inspected under the social care common inspection framework

Information about this children's home

This home provides care for up to seven children, aged eight to 17, who have learning disabilities and/or sensory impairment.

The manager has been registered since July 2019.

Inspection date: 3 March 2020

This monitoring visit

The monitoring inspection was undertaken after concerns were raised with Ofsted. At this monitoring visit, several shortfalls were identified.

The management of allegations about members of staff is poor. The manager's actions to address poor practice are inconsistent. Several of the internal investigations into allegations and identified practice concerns are incomplete. These failures mean that the children are not safeguarded as far as practicable.

The manager has not informed the designated officer of every allegation that has been made about members of the staff. He failed to investigate an allegation of staff making derogatory comments about the children. Aspects of the safeguarding records are incomplete. The records are not all signed by the author and there are discrepancies in some of the records. In some cases, it is not clear if the placing authorities have been informed. There are investigations that have no recorded outcome and, in some cases, no record of the actual allegation or the actions taken in response. These failures mean that there are ineffective safeguards for the children and that actions are not in accordance with the home's safeguarding policy.

The manager has failed to inform Ofsted of allegations and serious concerns about the staff's practice. A failure to notify means that Ofsted does not have up-to-date information about the home and how well the children are protected.

The manager has failed to provide support when the staff clearly need guidance and monitoring. This is despite records that detail a member of staff making

inappropriate comments and behaving negatively towards the children. This fails to safeguard the children or properly monitor poor practice.

The home's location risk assessment does not include an assessment of the use of the home's gates as a measure to keep the children safe. Therefore, not all possible action to reduce risks to the children has been considered.

The staff have applied some unreasonable sanctions. On one occasion, a sanction that was applied to a child who had expressed thoughts of self-harm actually caused some self-harm. There is no record of any other behaviour to warrant the measure of control that was used. Use of an unreasonable sanction happened on a second occasion, demonstrating that the manager fails to monitor the sanction records and discuss whether the staff's actions are justified, meaningful and proportionate.

The internal and external monitoring of the home is weak. The managerial monitoring is hindered by a failure to hold information centrally. The records of allegations and concerns about staff's practice are held in staff supervision and recruitment files and held electronically. This makes the records difficult to audit and monitor comprehensively and, therefore, areas for improvement are not identified. This reduces the effectiveness of the safeguards intended through this monitoring.

This monitoring visit identified some aspects of positive practice. The staff spoke positively about the children. The staff enjoy their work. They were clear about the actions that they would take if they had a concern. The interactions observed between the staff and the children were positive.

The staff provide high levels of supervision to the children. Effective communication between the separate houses where the children live ensures that the staff can request extra support if required. The staff confirmed that the children access activities and have made progress living at the home. A social worker supported this view.

The manager has taken swift action in response to some concerns regarding staff practice, and two of the staff have been dismissed. The records of staff's supervision indicate that, in these cases, there have been no further concerns about practice and the quality of care has improved.

The management has reflected on a child's placement breakdown following a significant incident. It has considered possible actions that may reduce the risk of a recurrence in a similar situation.

Two of the four requirements and three recommendations made at the last inspection were not monitored at this inspection. These will be reviewed at the next inspection.

Recommendations

■ Keep the statement of purpose under review. The statement of purpose should be child-focused, indicating how the home provides individualised care to meet the Quality Standards for the children in its care. ('Guide to the children's homes regulations including the quality standards', page 14, paragraph 3.5)

In particular, provide details of the calm room.

- Ensure that staff follow and understand Managing medicines in care homes (March 2014). ('Guide to the children's homes regulations including the quality standards', page 35, paragraph 7.17)
- Ensure that all staff can access appropriate facilities and resources to support their training needs. ('Guide to the children's homes regulations including the quality standards', page 53, paragraph 10.11)

In particular, provide training in understanding mental health, anxiety and depression.
